

That, in view of the above, the College of Physicians and Surgeons of the Province of Quebec has consented to the passing of an act authorizing him to practise medicine after passing the necessary medical examinations for obtaining a license, before the board of examiners of the said college;

Whereas the petitioner has prayed that an act be passed to that effect; and whereas it is expedient to grant his prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said Ernest Brault among its members, and to grant him the necessary licence to practise medicine in the Province, after examination.  
College of Physicians and Surgeons authorized to admit E. Brault to practice.
2. This act shall come into force on the day of its sanction.

#### C H A P. 134

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Charles Henry Barr to the practice of dentistry

[Assented to 22nd December, 1916]

**W**HEREAS Charles Henry Barr, of the city and district of Montreal, doctor of dental science, has been admitted to follow and has followed a complete course and taken clinical training in dentistry in the school of dental surgery of McGill University, Montreal, from which, after due examination, he has graduated and received the diploma of doctor of dental science on the 13th of September, 1916; Preamble.

Whereas he has, in consequence of his studies and experience, all the knowledge and title required of a practising dental surgeon, and the necessary competence to practise as such;

Whereas since obtaining said diploma of doctor of dental science, he has been prevented from being examined by the Board of Governors of the College of Dental Surgeons of the Province of Quebec for the practice of dentistry, owing to the fact that he only completed on the 13th of

September, 1916, his examination for admission to study dentistry, but was on that date duly admitted, having previously graduated and received the diploma of doctor of dental science as aforesaid;

Whereas the Board of Governors of the College of Dental Surgeons of the Province of Quebec have approved of an act being passed to authorize the College of Dental Surgeons of the Province of Quebec to admit the said Charles Henry Barr among its members, and to authorize him to practise dentistry, after final examination for the practice of dentistry;

Whereas he has prayed, by his petition, that an act be passed to that effect, and it is expedient to grant such prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

College of Dental Surgeons authorized to admit C. H. Barr to practice. **1.** The College of Dental Surgeons of the Province of Quebec is hereby authorized to admit the said Charles Henry Barr among its members, and to grant him the necessary license to practise dentistry in this Province, after final examination for the practice of dentistry.

Coming into force. **2.** This act shall come into force on the day of its sanction.

## C H A P. 135

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Joseph Orphir Emile Brunet among its members

[Assented to 22nd December, 1916]

Preamble. **W**HEREAS Joseph Orphir Emile Brunet, of the city and district of Montreal, has, by his petition, represented:

That he is twenty-seven years old;

That he matriculated as a student of the school of dental surgery of Laval University, in Montreal, in September, 1911;

That he followed the course of lectures of the school for the four regulation university years;

That in April, 1915, he passed his university examinations, and was awarded the degree of Doctor of Dental Surgery;

That in September, 1916, he presented himself again
