

September, 1916, his examination for admission to study dentistry, but was on that date duly admitted, having previously graduated and received the diploma of doctor of dental science as aforesaid;

Whereas the Board of Governors of the College of Dental Surgeons of the Province of Quebec have approved of an act being passed to authorize the College of Dental Surgeons of the Province of Quebec to admit the said Charles Henry Barr among its members, and to authorize him to practise dentistry, after final examination for the practice of dentistry;

Whereas he has prayed, by his petition, that an act be passed to that effect, and it is expedient to grant such prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

College of Dental Surgeons authorized to admit C. H. Barr to practice.

1. The College of Dental Surgeons of the Province of Quebec is hereby authorized to admit the said Charles Henry Barr among its members, and to grant him the necessary license to practise dentistry in this Province, after final examination for the practice of dentistry.

Coming into force.

2. This act shall come into force on the day of its sanction.

C H A P. 135

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Joseph Orophir Emile Brunet among its members

[Assented to 22nd December, 1916]

Preamble. **W**HEREAS Joseph Orophir Emile Brunet, of the city and district of Montreal, has, by his petition, re-presented:

That he is twenty-seven years old;

That he matriculated as a student of the school of dental surgery of Laval University, in Montreal, in September, 1911;

That he followed the course of lectures of the school for the four regulation university years;

That in April, 1915, he passed his university examinations, and was awarded the degree of Doctor of Dental Surgery;

That in September, 1916, he presented himself again

before the College of Dental Surgeons of the Province of Quebec, and passed the examination in the Sciences and in Letters, and was regularly admitted to the study of dentistry;

That, before that date, his pecuniary means prevented his presenting himself for said examinations;

That owing to his studies, his qualifications and probation, the Board of Governors of the College of Dental Surgeons of the Province of Quebec has consented to the passing of an act to authorize the said college to grant the petitioner a license to practise, as dentist, after the final examinations;

Whereas it is expedient to grant the prayer to that effect contained in said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Joseph Orphir Emile Brunet among its members, and to grant him the necessary license for the practice of dental surgery in the Province of Quebec, after final examination.
