

admission to study dental surgery, and passed for the "Sciences" part of the said examination;

That in April, 1913, he passed his university examinations and was awarded the degree of Doctor of Dental Surgery;

That later, in September, 1916, he presented himself again before the examiners of the said college, to complete the necessary examinations for admission to the study of dental surgery, and that he then passed the examination for the "Letters" part, and was regularly admitted to the study of dental surgery;

That owing to his studies and his qualifications and probation, the Board of Governors of the College of Dental Surgeons of the Province of Quebec has consented to the passing of an act to authorize the said college to grant the petitioner a license to practise his profession after an examination on final subjects;

And whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Trancrede Asselin among its members, and to grant him the necessary license for the practice of dental surgery in the Province of Quebec, after an examination on final subjects.

C H A P. 137

An Act to authorize the College of Dental Surgeons of
the Province of Quebec to admit Frederic William
Saunders to the practice of dentistry

[Assented to 22nd December, 1916]

Preamble.

WHEREAS Frederic William Saunders, of the city and district of Montreal, doctor of dental science, has been duly admitted to follow and has followed a complete course and taken clinical training in dentistry in the school of dental surgery of McGill University, Montreal, from which, after due examination, he has graduated and received the diploma of doctor of dental science on the 12th of May, 1916;

Whereas he has, in consequence of his studies and experience, all the knowledge and title required of a practising dental surgeon and the necessary competence to practise as such;

Whereas before and since obtaining said diploma of doctor of dental science, he has been prevented from being examined by the Board of Governors of the College of Dental Surgeons of the Province of Quebec for the practice of dentistry, owing to the fact of his engagement and service with the medical corps of the First Canadian Overseas Expeditionary Force in England and France, and has so served until lately, in the course of which service he has acquired further experience;

Whereas the Board of Governors of the College of Dental Surgeons of the Province of Quebec have approved of an act being passed to authorize the College of Dental Surgeons of the Province of Quebec to admit said Frederic William Saunders among its members, and to authorize him to practise dentistry after final examination for the practice of dentistry;

Whereas he has prayed, by his petition, that an act be passed to that effect, and it is expedient to grant such prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is hereby authorized to admit the said Frederic William Saunders among its members, and to grant him the necessary license to practise dentistry in this Province, after final examination for the practice of dentistry.
