

School municipality annexed to Cath. School Com. of Montreal. **1.** The school municipality of the town of Maisonneuve, now the city of Maisonneuve, in the county of Maisonneuve, is annexed to the school municipality under the jurisdiction and control of the Catholic School Commission of Montreal.

Vesting of rights, &c. **2.** From and after the date of such annexation the Catholic School Commission of Montreal shall be vested with the rights and subject to the obligations of the school commissioners of the municipality of the town of Maisonneuve, now the city of Maisonneuve, in the county of Maisonneuve, and the assets and liabilities of the latter shall be merged with the assets and liabilities of the said commission.

Bond issue cancelled. **3.** The bond issue made by the school commissioners of the town of Maisonneuve, by resolution of the 8th of June, 1915, is cancelled; but the Catholic School Commission of Montreal is authorized to borrow a sum of not more than eight hundred thousand dollars for the school purposes of the annexed commission.

Loan authorized.

Annual school tax to be imposed by city of Maisonneuve. **4.** The council of the city of Maisonneuve shall, before the first of November each year, impose an annual school tax upon the property taxable for school purposes. Such tax, the amount of which shall be fifty cents in every hundred dollars, shall be collected by the city of Maisonneuve, and forthwith handed over to the city of Montreal for the benefit of the Catholic School Commission of Montreal, as to the share to which the latter is entitled, and, as to the other part, to the trustees of the dissenting schools of the city of Maisonneuve.

Disposal of proceeds.

Coming into force. **5.** This act shall come into force on the day of its sanction.

C H A P . 6 6

An Act to amend the school municipality of the village of La Côte de la Visitation de Montréal, to that of the Catholic School Commission of Montreal.

[Assented to 9th March, 1916]

Preamble. **W**HEREAS the school commissioners of the school municipality of the village of La Côte de la Visitation de Montréal, in the Counties of Maisonneuve and Montreal-Dorion, have, by their petition, represented that it is

in their interest, and in that of education generally, that their school municipality be annexed to that of the Catholic School Commission of Montreal, and whereas it is expedient to grant their prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The school municipality of the village of La Côte de la Visitation de Montréal in the counties of Maisonneuve and Montreal-Dorion, is annexed to the school municipality under the jurisdiction and control of the Catholic School Commission of Montreal.

2. From the date of such annexation the Catholic School Commission of Montreal shall be vested with the rights and subject to the obligations of the school commissioners of the municipality of the village of La Côte de la Visitation de Montréal in the counties of Maisonneuve and Montreal-Dorion, and the assets and liabilities of the latter shall be merged with the assets and liabilities of the said commission.

CHAP. 67

An Act to annex the separate school municipality of the parish of St. Michael the Archangel of Montreal to that of the Catholic School Commission of Montreal.

[Assented to 16th March, 1916]

WHEREAS the Catholic school commissioners for separate schools of the parish of St. Michael the Archangel of Montreal have, by their petition, represented that it is in the interest of education generally, and of their municipality in particular, that the latter be annexed to that of the Catholic School Commission of Montreal, and whereas it is expedient to grant their prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
