1. The school municipality of the village of La Côte de la Visitation de Montréal in the counties of Maisonneuve and Montreal-Dorion, is annexed to the school municipality under the jurisdiction and control of the Catholic School Commission of Montreal.

2. From the date of such annexation the Catholic School Commission of Montreal shall be vested with the rights and subject to the obligations of the school commissioners of the municipality of the village of La Côte de la Visitation de Montréal in the counties of Maisonneuve and Montreal-Dorion, and the assets and liabilities of the latter shall be merged with the assets and liabilities of the said commission.

CHAP. 67

An Act to annex the separate school municipality of the parish of St. Michael the Archangel of Montreal to that of the Catholic School Commission of Montreal.

[Assented to 16th March, 1916]

WHEREAS the Catholic school commissioners for separate schools of the parish of St. Michael the Archangel of Montreal have, by their petition, represented that it is in the interest of education generally, and of their municipality in particular, that the latter be annexed to that of the Catholic School Commission of Montreal, and whereas it is expedient to grant their prayer;

Preamble.

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The separate school municipality of the parish of St. Michael the Archangel of Montreal, is annexed to the school municipality under the jurisdiction and con-

Madeleine d'Outremont, which portions of territory shall, subject to the provisions of article 2596 of the Revised Statutes, 1909, be annexed to the aforesaid municipalities in which they shall be respectively included.

Vesting of rights, &c. **2.** From the date of such annexation, the Catholic School Commission of Montreal shall be vested with the rights and subject to the obligations of the school commissioners for the separate school municipality of the parish of St. Michael the Archangel of Montreal, and the assets and liabilities of the latter shall be merged with the assets and liabilities of the said commission.

Provisions repealed. The acts 6 Edward VII, chapter 86, and 2 George V, chapter 80, are repealed.

Coming into force. **3.** This act shall come into force on the 1st July, 1916, but until then the school commissioners of St. Michael the Archangel shall not contract any new obligations.

C H A P . 6 8

An Act to annex the school municipality of St. Edward, to that of the Catholic School Commission of Montreal.

[Assented to 9th March, 1916]

Preamble. **W**HEREAS the school commissioners of the school municipality of St. Edward, in the electoral division of Montreal-Dorion and Montreal-Laurier, have, by their petition, represented that it is in their interest, in that of education generally, and in that of the Catholic School Commission of Montreal, that their school municipality be annexed to that of the said commission; and whereas it is expedient to grant their prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Annexation to Cath. Sch. Com. of Montreal. **1.** The school municipality of St. Edward, in the electoral division of Montreal-Dorion and Montreal-Laurier, is annexed to the school municipality under the jurisdiction and control of the Catholic School Commission of Montreal.
