

CHAP. 98

An Act to amend the charter of the Sunday School Union of Montreal.

[Assented to 16th March, 1916]

Preamble.

WHEREAS the Sunday School Union of the Province of Quebec, a body corporate, incorporated by act of this Legislature, 51-52 Victoria (1888), chapter 61, has by its petition asked that the act of incorporation be amended by changing the word "Union" in said act where it refers to said association, to the word "Association," as being in harmony with other similar state and provincial organizations in which the word "Association" is almost universally used; and to change the word "five" to "seven" in the sixth section, to give a little more latitude in the selection of the general committee;

And whereas it is expedient to grant its petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The act 51-52 Victoria, chapter 61, is amended :

a. By replacing section 1 thereof by the following:

"**1.** Henry Lyman, J. Murray Smith, Seth P. Leet, George Bishop, David Bentley, Reginald H. Buchanan, Geo. Hague, D. Torrance Fraser, Theodore Lyman, L. H. Packard, Abner Kingman, William Tees, J. H. Carson, J. H. Cayford, Jas. Croil, James C. Holden, and John E. Kirkpatrick, of the city of Montreal, and any others who may now be members of the Canada Sunday School Union, and all others who may hereafter become members, are hereby constituted a body politic and corporate, under the name of the 'Sunday School Association of the Province of Quebec,' with its head office in the city of Montreal.";

b. By replacing the word: "Union," wherever it appears in the said act as referring to the said corporation created thereby, by the word: "Association".

2. Section 6 of the said act 51-52 Victoria, chapter 61, is replaced by the following:

General
committee.

"**6.** The business and property of the said association shall be managed by a general committee, composed of twenty-one persons who shall be members of the said association and also members in good standing of some

Evangelical Protestant Church, and of whom not more than seven shall belong to any one denomination.

The said committee shall be elected for such term and in such manner as may be provided in the constitution and by-laws of the said association."

C H A P . 9 9

An Act to incorporate the "Fire Insurance Brokers' Association of Montreal."

[Assented to 16th March, 1916]

WHEREAS the persons hereinafter named have by Preamble.
their petition represented that it would be in the general interest of the public that said association should be incorporated in order to promote by all legal means the best interests and practice of the business of fire insurance, and have prayed that it may be enacted as hereinafter set forth;

Whereas it is expedient to grant the prayer of the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Courtois, both of the city of Montreal, Isidore Crepeau, created.
and Robert J. Wickham, of the city of Outremont, Peter W. A. Burket, of the city of Westmount, and Emmanuel Gauthier, of the city of Maisonneuve, all fire insurance brokers, and all other persons who may from time to time be admitted to membership of the corporation, are hereby constituted a body politic and corporate by the name of the "Fire Insurance Brokers' Association of Name.
