

the 9th September, 1914, and that since that date he has been attached to the office of Mr. René Chênevert, advocate, of the Montreal Bar;

That he has followed a complete course of legal studies at Laval University, Montreal, from which he obtained the diploma of Bachelor in Law;

That he passed the examinations for admission to the practice of law, held on the 6th of July last by the Bar of the Province of Quebec;

That he was unable to present himself for examination for admission to the study of law before the 9th of July, 1914;

That the General Council of the Bar of the Province of Quebec, at its last meeting held at Three Rivers, approved the passing of an act to allow the petitioner to be admitted to the practice of law;

Whereas the said Joseph Phileas Philippe Caumartin has prayed for the passing of an act for the above purposes; and it is expedient to grant the prayer contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is authorized to admit Joseph Phileas Philippe Caumartin to practise law immediately. Bar may admit J. J. P. Caumartin to practise.
2. This act shall come into force on the day of its sanction. Coming into force.

C H A P . 1 1 2

An Act to authorize the Bar of the Province of Quebec to admit Solon Eliasoph amongst its members.

[Assented to 16th March, 1916]

WHEREAS Solon Eliasoph of the City of Montreal, Preamble. has, by his petition, represented:

That he entered the faculty of law of McGill University in October, 1911, and followed a regular course of law and passed the prescribed examinations, and in May, 1915, received his degree of Bachelor of Civil Law;

That he was indentured as a student of law for a period of three years from the first day of October, 1912;

That he passed the admission to study law examination

on "Letters" in January 1908, and "Sciences" in January 1915;

That he presented himself before the examiners of the Bar of the Province of Québec, and passed the examination for admission to practise the profession of advocate in July, 1915, and was duly sworn in, subject to the expiration of his indenture;

That he completed all the studies and requirements for admission to practise law with the exception of following his indenture for the required three years since his final admission to study;

That the Montreal Local Council and the General Council of the Bar of the Province of Quebec have approved of the passing of an act to authorize the Bar of the Province of Quebec to admit him to the practice of law forthwith;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is hereby authorized to permit the said Solon Eliasoph to practise as an advocate, and the Secretary of the General Council of the Bar to issue to him his certificate as an advocate.

2. This act shall come into force on the day of its sanction.

CHAP. 113

An Act to authorize the Bar of the Province of Quebec to admit Louis René Gagné amongst its members and to grant him his diploma as advocate.

[Assented to 9th March, 1916]

Preamble.

WHEREAS Louis René Gagné, of the city of Quebec, has by his petition represented:

That, by the act 4 George V, chapter 167, assented to on the 19th of February, 1914, the Bar of the Province of Quebec was authorized to admit him to the examinations for admission to the practice of law on condition that he previously obtain a degree in law from a university and the required certificate from his patron, and to admit him amongst its members as soon as he passed the examination for admission to the study of law;
