That he presented himself before the examiners of the Bar of the Province of Québec, and passed the examination for admission to practise the profession of advocate in July, 1915, and was duly sworn in, subject to the expiration of his indenture;

That he completed all the studies and requirements for admission to practise law with the exception of following his indenture for the required three years since his final admission to study;

That the Montreal Local Council and the General Council of the Bar of the Province of Quebec have approved of the passing of an act to authorize the Bar of the Province of Quebec to admit him to the practice of law forthwith;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Bar of the Province of Quebec is hereby authorized to permit the said Solon Eliasoph to practise as an advocate, and the Secretary of the General Council of the Bar to issue to him his certificate as an advocate.

## CHAP. 113

An Act to authorize the Bar of the Province of Quebec to admit Louis René Gagné amongst its members and to grant him his diploma as advocate.

[Assented to 9th March, 1916]

Preamble.

**W**HEREAS Louis René Gagné, of the city of Quebec, has by his petition represented:

That, by the act 4 George V, chapter 167, assented to on the 19th of February, 1914, the Bar of the Province of Quebec was authorized to admit him to the examinations for admission to the practice of law on condition that he previously obtain a degree in law from a university and the required certificate from his patron, and to admit him amongst its members as soon as he passed the examination for admission to the study of law;

That in July, 1915, after having obtained the degree of Bachelor in Law at Laval University, and the required certificate from his patron, he successfully passed the examinations for the admission to the practice of law;

That for special reasons alleged in a petition to the General Council of the Bar of the Province of Quebec, it is impossible for him to present himself at the examinations for admission to the study of law;

That he is twenty-nine years old and he is in great danger of losing the fruit of his studies in law and of his examinations;

That on the fifteenth day of October, 1915, the members of the Council of the Quebec Bar unanimously adopted a resolution approving this bill;

That on the 29th day of October, 1915, he applied to the General Council of the Bar of the Province of Quebec, to obtain the authorization to present this bill to the Legislature;

That the said General Council authorized the introducing of a bill for the purposes aforesaid;

And whereas it is expedient to grant the prayer to that effect contained in the said petition:

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Bar of the Province of Quebec is hereby authorized to immediately admit Louis René Gagné among its members, and to grant him his diploma as advocate as if he had passed the examination for admission to the study of law. Bar of Province authorized to admit L. R. Gagné to practise.

**2.** This act shall come into force on the day of its sanction. Coming into force.

An Act to authorize the Bar of the Province of Quebec to admit Maurice Goudrault among its members after examination.
