

C H A P . 1 1 5

An Act to authorize the Bar of the Province of Quebec to admit Robert Warden Lee among its members, after examination.

[Assented to 16th March, 1916]

WHEREAS Robert Warden Lee of the city and district of Montreal, Dean of the Faculty of Law of McGill University, has, by his petition, represented that he is a Master of Arts and a Bachelor of Civil Law of the University of Oxford, and that he is a Barrister-at-Law in good standing of Gray's Inn, London, England, and an advocate in good standing of the Supreme Court of the Union of South Africa; and that he is desirous of being admitted as a member of the Bar of the Province of Quebec, after such examination as the said Bar shall see fit to require;

And whereas the General Council of the Bar of the Province of Quebec has approved of the petitioner's application, and has consented to grant the petition of said petitioner;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is hereby authorized to admit the said Robert Warden Lee among its members after such examination as it shall see fit to require.
2. This act shall come into force on the day of its sanction.

Bar of Province authorized to admit R. W. Lee to practise. Coming into force.

C H A P . 1 1 6

An Act to authorize the Bar of the Province of Quebec to admit Joseph Pamphile Lemay among its members, after examination.

[Assented to 16th March, 1916]

WHEREAS Joseph Pamphile Lemay, student at law, of the city of Montreal, district of Montreal, has by his petition represented:

That he was born at Manchester, New Hampshire, one of the United States of North America, on the 4th December, 1891, and that his father was a British subject who had never given up his allegiance;

That he followed a course of classical studies at the Manchester High School, in Manchester, New Hampshire, and that he obtained the diploma awarded by such school;

That he passed the examinations before the College Entrance Examinations Board for Harvard University at Cambridge, and that he holds the said certificate of examination;

That in July, 1911, he went to Paris in France and passed an examination on philosophy to obtain the title of Bachelor of Philosophy in 1909, bearing number 225, with Professor Nicolas Thierry, L.H.D.;

That he was admitted to the study of law for the State of New Hampshire on 29th April, 1908;

That in April, 1908, he entered the law faculty of the American Correspondence School of Law of Chicago, Illinois, one of the United States of North America, and that he was awarded the diploma of the said faculty of law on the 12th May, 1911, after having followed the course of study and passed the examinations;

That he came to reside in Montreal, on the 28th June, 1911;

That in September, 1911, he began to study law in the office of Mr. A. Papineau Mathieu, advocate, of the city of Montreal, and that he attended the said office regularly until the month of January, 1913;

That in January, 1912, he entered the law faculty of Laval University of Montreal, and followed a law course during the year 1912-1913;

That owing to financial reasons he was obliged to interrupt his studies in law at Laval University;

That in January, 1913, he entered the office of Mr. J. A. Hurteau, advocate, practising in the city of Montreal, and that he has attended such office regularly to date;

That owing to his not being regularly admitted to the study of law, he is in great danger of losing the fruits of his legal studies;

That the General Council of the Bar of the Province of Quebec, at a general meeting held in the city of Three Rivers on 29th October, 1915, unanimously approved the passing of an act authorizing the petitioner to be admitted to the examination for admission to the practice of law, and to admit him among its members after such examination;

And whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent

of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is authorized to admit the said Joseph Pamphile Lemay among its members, and to allow him to practise the profession of advocate as soon as he has passed the examination for admission to the practice of law. Bar authorized to admit J. P. Lemay to practice.

2. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 117

An Act to authorize Jean Marie Richard to practise law after examination.

[Assented to 16th March, 1916]

WHEREAS Jean Marie Richard, notary, of St. Ours, has, by his petition, represented: Preamble.

That he was admitted to the practice of the notarial profession on the 22nd July, 1903, after having been regularly indentured and passed the examinations before the Board of Notaries of the Province of Quebec;

That he has practised the notarial profession at St. Ours since the 31st of August, 1903;

That he now wishes to cease practising that profession in order to be admitted to the practice of law;

That upon presentation of his diploma of Bachelor of Arts of Laval University, he was admitted to the study of law, on the 14th day of January, 1915;

That on the 10th of June, 1915, the general council of the Bar of the Province of Quebec approved the passing of this act;

Whereas the said petitioner has prayed for the passing of an act for the above purposes, and it is expedient to grant his prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is authorized to admit the said Jean Marie Richard to the final examination for admission to the practice of law, and to admit him among its members after examination. Bar of Province authorized to admit J. M. Richard to practise.

2. This act shall come into force on the day of its sanction. Coming into force.
