

Whereas the petitioner has prayed that an act be passed for the above purpose, and it is expedient to grant his prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Bar of the Province of Quebec is authorized to allow Benjamin Shulman to present himself at the examination for admission to the practice of law at the next sitting, July, 1916, and to admit him among its members after passing the said examination and the examination for admission to the study of law.

**2.** This act shall come into force on the day of its sanction.

## CHAP. 119

An Act to regularize the clerkship of Edmond St. Denis, student at law.

[Assented to 16th March, 1916]

**WHEREAS** Edmond St. Denis, student at law, of Montreal, has, by his petition, represented:

That he is holder of a diploma of Bachelor of Sciences of Laval University, dated 13th July, 1912, and that, on the 23rd of January, 1913, he was indentured with A. J. H. St. Denis, Notary, of Montreal, which indenture was registered in the said month of January of the same year at the office of the secretary of the Board of Notaries at Montreal;

That from the date of his indenture he worked assiduously in the office of the said notary, and that he followed the lectures of the law faculty of Laval University in Montreal, given during the years 1912-1913, 1913-1914 and 1914-1915;

That he was admitted to the study of the notarial profession at the sitting of the Board of Notaries held in 1915;

That he has obtained the authorization of the Board of Notaries to introduce a bill to make the date of his clerkship count back to the date of his indenture;

And whereas the petitioner has prayed for the passing

of an act for the above purposes, and it is expedient to grant his prayer;

**1.** The clerkship of Edmond St. Denis, student at law, of Montreal, shall count back to the date of his indenture, 23rd January, 1913, though he did not apply for admission to the study of the notarial profession at the session of the board of notaries immediately following the date of his indenture.

## CHAP. 120

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Gilles R. Amiot among its members.

*[Assented to 16th March, 1916]*

Preamble.

**WHEREAS** Gilles R. Amiot, of the city and district of Montreal, student, has by his petition represented: That in October, 1911, he was matriculated as a student of the school of dental surgery of Laval University, in Montreal;

That he followed the course of lectures of that school for the four regulation university years;

That in the month of April, 1915, he passed his university examinations, before assessors representing the College of Dental Surgeons of the Province of Quebec, and was awarded the degree of Doctor of Dental Surgery;

That owing to circumstances beyond his control, he was unable to present himself at the examinations for admission to the study of dental surgery, before entering the school of dental surgery of Laval University in Montreal;

That in the month of September, 1913, he presented himself before the board of examiners of the College of Dental Surgeons of the Province of Quebec, and passed the examination for admission to the study of dental surgery;

That owing to his studies and his experience and his qualifications above mentioned, he possesses the necessary knowledge and titles for a practising dentist;
