

That in the month of April, 1915, he passed his university examinations in the presence of the assessors representing the College of Dental Surgeons of the Province of Quebec, and was awarded the degree of Doctor of Dental Surgery, with distinction;

That owing to circumstances beyond his control, he was unable to present himself at the examinations for admission to the study of dental surgery, before entering the school of dental surgery of Laval University in Montreal;

That in the month of September, 1914, he presented himself before the board of examiners of the College of Dental Surgery of the Province of Quebec, and passed the examination for admission to the study of dental surgery;

That owing to his studies and experience and his qualifications as above stated, he possesses the knowledge and titles required for a practising dentist;

That he has obtained the authorization of the Board of Governors of the College of Dental Surgeons of the Province of Quebec for introducing a bill to authorize the College of Dental Surgeons of the Province of Quebec to admit him among its members and to grant him a license to practise dental surgery without further delay;

Whereas the petitioner has, by his petition, prayed that an act be passed to that effect, and it is expedient to grant his prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Elie Jobin among its members, and to grant him the necessary license for the practice of dental surgery in the Province.

## CHAP. 126

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Joseph Labreque among its members

[Assented to 9th March, 1916]

Preamble.

**W**HEREAS Joseph Labreque, of the city and district of Quebec, student, has by his petition represented: That in September, 1911, he was matriculated as a student

of the school of dental surgery of Laval University, in Montreal;

That he followed the course of lectures of that school for the four regulation university years;

That in the month of April, 1915, he passed his university examinations in the presence of the assessors representing the College of Dental Surgeons of the Province of Quebec, and was awarded the degree of Doctor of Dental Surgery;

That owing to circumstances beyond his control he was unable to present himself at the examinations for admission to the study of dental surgery, before entering the school of dental surgery of Laval University in Montreal;

That in the month of September, 1914, he presented himself before the board of examiners of the College of Dental Surgery of the Province of Quebec, and passed the examination for admission to the study of dental surgery;

That owing to his studies and experience and his qualifications as above stated, he possesses the knowledge and titles required for a practising dentist;

That the Board of Governors of the College of Dental Surgeons of the Province of Quebec has approved of the passing of an act to authorize the College of Dental Surgeons of the Province of Quebec to regularize the petitioner's clerkship and to admit him among its members;

Whereas the petitioner has, by his petition, prayed that an act be passed to that effect, and it is expedient to grant his prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The clerkship of the said Joseph Labreque is regularized, and the College of Dental Surgeons of the Province of Quebec is authorized to admit him among its members, and to grant him the necessary license for the practice of dental surgery in the Province.
