CHAP. 128

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Leopold Larocque among its members.

[Assented to 16th March, 1916]

WHEREAS Leopold Larocque, of the city and district of Montreal, student, has by his petition represented:

Preamble.

That he is thirty years old;

That in the month of September, 1909, he was matriculated as a student of dental surgery at Laval University in Montreal;

That he followed the course of lectures of that school for four regulation university years;

That in April, 1913, he passed his university examinations and was awarded the degree of Doctor of Dental Surgery;

That in April, 1914, he presented himself before the board of examiners of the College of Dental Surgeons of the Province of Quebec to pass the examination for admission to the study of dental surgery, and passed for the 'Letters' part of the said examination;

That later, in April, 1915, he presented himself again before the examiners of the said college, to complete the necessary examinations for admission to the study of dental surgery, and that he then passed the said examination for the 'Sciences' part, and was regularly admitted to the study of dental surgery;

That owing to his studies, his qualifications, and his age, the Board of Governors of the College of Dental Surgeons of the Province of Quebec has consented to the passing of an act to authorize the said college to grant the petitioner a license to practise his profession after an examination on primary and final subjects;

Whereas it is expedient to grant the prayer to that effect contained in his petition;

Therefore His Majesty, with the advice and consent of the Legislative council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Leopold Larocque among its members, and to grant him the necessary license for the practice of dental surgery in the Province after his examination on primary and final subjects.

CHAP. 129

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Albert Lavigne among its members.

[Assented to 9th March, 1916]

Preamble.

WHEREAS Albert Lavigne, of the city and district of Montreal, student, has by his petition represented:

That he is 29 years old;

That in September, 1909, he was matriculated as a student of the school of dental surgery of Laval University, in Montreal;

That he followed the course of lectures of that school for the four regulation university years;

That in the month of April, 1913, he passed his university examinations and was awarded the degree of Doctor of Dental Surgery;

That in January, 1916, Laval University awarded him the degree of Bachelor of Letters;

That owing to his studies, his qualifications and probation, the Board of Governors of the College of Dental Surgeons of the Province of Quebec has consented to the passing of an act authorizing the said College to grant him a license to practise dental surgery after examination on primary and final subjects;

Whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
