An Act to authorize the College of Dental Surgeons of
 the Province of Quebec to admit Alexander Walker
 Thornton among its members.

[Assented to 16th March, 1916]

Preamble. **W**HEREAS Alexander Walker Thornton, of the city
 and district of Montreal, Doctor of Dental Surgery,
 has by his petition represented:

That he obtained the degree of Doctor of Dental
 Surgery from the University of Toronto in the year 1890;

That in the said year 1890 he obtained a license to
 practise dentistry in the Province of Ontario from the
 Royal College of Dental Surgeons of Ontario;

That from the year 1903 to the year 1913, he was
 a member of the Faculty of the Royal College of Dental
 Surgeons of Ontario, and was professor of crown and bridge
 work;

That in the year 1913, he came to Montreal as
 head of the Department of Dentistry in McGill University;

That in the year 1914, he received the degree of
 Doctor of Dental Surgery from McGill University;

That owing to his studies and experience and his
 qualifications as above stated, he possesses the knowledge
 and titles required for a practising dentist;

That the Board of Governors of the College of
 Dental Surgeons of the Province of Quebec has approved
 the passing of an act to authorize the College of Dental
 Surgeons of the Province of Quebec to admit the petitioner
 among its members;

Whereas the petitioner has, by his petition, prayed that
 an act be passed to that effect, and it is expedient to grant
 his prayer;

Therefore His Majesty, with the advice and consent
 of the Legislative Council and of the Legislative Assembly
 of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Alexander Walker Thornton among its members, and to grant him the necessary license for the practice of dental surgery in the province.
2. This act shall come into force on the day of its sanction.

CHAP. 134

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Nathan Titleman among its members.

[Assented to 16th March, 1916]

WHEREAS Nathan Titleman, dental graduate, of the city and district of Montreal, has, by his petition, represented that he studied at the School of Dental Surgery of McGill University at Montreal, and completed four yearly sessions of the said school in the month of May, 1915, and received the degree of Doctor of Dental Surgery from the said McGill University;

Preamble.

That he has passed the requisite examinations to permit him to practise dental surgery in the Province of Quebec; and that on account of having passed the preliminary examinations for admission to study dental surgery only in September, 1914, he would in the ordinary course be obliged to wait four years from such date before being permitted to practise as a dentist in this Province;

That he is qualified in every way to practise as a dentist in the Province of Quebec, and that it would be a hardship to compel him to wait four years from September, 1914;

That the Board of Governors of the College of Dental Surgeons of the Province of Quebec have approved of the passing of an act to authorize the College of Dental Surgeons of the Province of Quebec to admit the petitioner as a member to practise dentistry in the said Province of Quebec;

Whereas the petitioner has prayed by his petition that an act be passed to that effect, and it is expedient to grant his prayer.

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
