1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Nathan Titleman among its members, and to grant him the necessary license for the practice of dental surgery in the Province.

2. This act shall come into force on the day of its sanction.

CHAP. 135

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Charles Edouard Valiquette among its members.

[Assented to 16th March, 1916]

Preamble.

WHEREAS Charles Edouard Valiquette, of Montreal, holder of a diploma of Doctor of Dental Surgery of the Baltimore College of Dental Surgery, has, by his petition, represented:

That he was awarded the diploma of Doctor of Dental Surgery by the Baltimore College of Dental Surgery, in the State of Maryland, one of the United States of America, in the month of May, 1914, where he followed the lectures and the clinics of said college of surgery during three years;

That he has been a member of the Harris-Hayden Odontological Society of Baltimore since the month of May, 1914;

That since he received his degree from the Baltimore College of Dental Surgery he has worked in Montreal as a duly registered assistant in a dentist's office;

That owing to his studies and experience he possesses the knowledge required for practising dentistry, and that he is well qualified to practise the said profession;

That he wishes to be admitted among the members of the College of Dental Surgeons of the Province of Quebec;

That the Board of Governors of the College of Dental Surgeons of the Province of Quebec has approved the passing of an act to authorize the College of Dental Surgeons of the Province of Quebec to admit the said Charles Edouard Valiquette among its members, and to grant him the necessary license for the practice of his profession after primary and final examinations and a year of lectures and clinical surgery in a school of dental surgery in the Province of Quebec;

And whereas it is expedient to grant the prayer of the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Charles Edouard Valiquette among its members, and to grant him the necessary license for the practice of dental surgery in the Province after passing the examination for admission to study, and the primary and final examinations, and after a year of lectures and clinical surgery in a school of dental surgery in the Province of Quebec.

CHAP. 136

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit James McK. Wathen among its members.

[Assented to 16th March, 1916]

WHEREAS James McK. Wathen, of the city and district of Montreal, student, has by his petition represented:

Preamble.

That he is 29 years old;

That in the month of September, 1909, he was matriculated as a student of dental surgery at McGill University in Montreal;

That he followed the course of lectures of that school for the four regulation university years;

That in May, 1913, he passed his university examinations and was awarded the degree of Doctor of Dental Surgery;

That in September, 1914, he presented himself before the board of examiners of the College of Dental Surgeons of the Province of Quebec to pass the examination for admission to the study of dental surgery, and passed for the 'Letters' part of said examination;

That later, in September, 1915, he presented himself again before the examiners of the said college, to complete the necessary examinations for admission to the study of dental surgery, and that he passed the same examination
