

C H A P . 2 9

An Act to amend the Revised Statutes, 1909, respecting certain grants to agricultural and other associations.

[Assented to 5th March, 1915]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

- R. S. 1851, am.** **1.** Article 1851 of the Revised Statutes, 1909, as amended by the act 1 George V (1st session), chapter 13, section 7, is again amended by replacing the words: "fifty-five thousand", in the first line of the second paragraph thereof, by the words: "one hundred thousand".
- R. S. 1855, am.** **2.** Article 1855 of the said statutes, as amended by the acts 1 George V (1st session), chapter 13, section 8, and 4 George V, chapter 14, section 1, is again amended by replacing the words: "fifty-five thousand", in the second line thereof, by the words: "one hundred thousand".
- R. S. 1893, am.** **3.** Article 1893 of the said statutes is amended by replacing the words: "fifty-five thousand", in the second line thereof, by the words: "one hundred thousand".
- Coming into force.** **4.** This act shall come into force on the day of its sanction.

C H A P . 3 0

An Act to amend the Revised Statutes, 1909, relating to farmers' clubs.

[Assented to 5th March, 1915]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

- R. S. 1872, am.** **1.** Article 1872 of the Revised Statutes, 1909, is amended by replacing the word "December", in the second line thereof, by the word "January".
- R. S. 1874, replaced.** **2.** Article 1874 of the said statutes is replaced by the following:

“1874. At such meeting the members who have paid ^{Election of} their subscriptions for the current year at least one hour ^{directors.} before the opening of the meeting, shall elect seven directors from among themselves, and appoint an auditor.

To be entitled to vote at such election, a member must ^{Qualification} be at least 16 years of age” ^{of voter.}

3. Article 1884 of the said statutes is amended by R. S. 1884, replacing the word “January”, in the seventh line thereof, ^{am.} by the word “February”.

4. Article 1885 of the said statutes is amended by R. S. 1885, replacing the word “February”, in the fourth line thereof, ^{am.} by the word “March”.

5. This act shall come into force on the day of its ^{Coming into} sanction. ^{force.}

C H A P . 3 1

An Act to amend the Revised Statutes, 1909, relating to the Dairy Association of the Province of Quebec, and to the manufacture of dairy products.

[Assented to 5th March, 1915]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 1959 of the Revised Statutes, 1909, is amend- ^{R. S. 1959,} ed by adding thereto two new paragraphs, as follows: ^{am.}

“The association shall consist of the persons who have ^{Who shall be} signed the declaration mentioned in this article, so long ^{members.} as they pay the annual subscription, and of all other persons who afterwards pay such annual subscription, after having been admitted to membership in the association.

The year for which a subscription is paid, shall begin ^{Subscription} on the first day of July, and end on the thirtieth day of June ^{Year.} following.”

2. Article 1963 of the said statutes, as amended by the ^{R. S. 1963,} act 3 George V, chapter 20, section 1, is replaced by the ^{replaced.} following:
