

**2.** Such additional bonds or debentures shall be issued in conformity with the act 54 Victoria, chapter 53. Provisions applicable.

**3.** The said bonds or debentures shall be in the same form as that authorized by the act 3 George V, chapter 29 save the necessary changes as to the amount of the issue, and date thereof, and the interest thereon. Form.

**4.** That portion of the territory lying within the limits of Bordeaux ward of the city of Montreal, which was annexed for municipal purposes to the city of Montreal, by virtue of section 2 of the act 4 George V, chapter 73, and was therein described as that part of the parish of St. Laurent, comprising lots Nos. 633 and 634 of the official plan and book of reference of the said parish of St. Laurent, shall, to all intents and purposes, form part of the territory of the Protestant School Municipality of the city of Montreal, and shall be considered to have so formed part of such territory since the 1st January, 1915. Territory annexed.

**5.** All acts of any nature whatsoever performed by the said Board or any of its officers, employees or agents in conformity with or in fulfilment of the terms of this act, subsequent to the first day of January, 1915, are hereby declared effective in the same manner and to the same extent as if this act had then been in force. Interpretation.

**6.** This act shall come into force on the day of its sanction. Coming into force.

#### C H A P . 4 0

An Act to annex the school municipality of the parish of St. Marc de Montreal to that of the Catholic School Commission of Montreal.

[Assented to 5th March, 1915]

**W**HEREAS the school commissioners of the municipality of the parish of St. Marc de Montreal, in the counties of Maisonneuve and Montreal-Dorion, have, by their petition, represented that it is in the interest of education generally, and of their municipality in particular, that it be annexed to that of the Catholic School Commission of Montreal; and it is expedient to grant their prayer; Preamble.  
Therefore, His Majesty, with the advice and consent of

the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**Annexation of school municipality.** **1.** The school municipality of the parish of St. Marc de Montreal, in the counties of Maisonneuve and Montreal-Dorion, is annexed to the school municipality under the jurisdiction and control of the Catholic School Commission of Montreal.

**Rights and obligations transferred.** **2.** From and after the date of the annexation, the Catholic School Commission of Montreal shall be vested with the rights and subject to the obligations of the school commissioners of the municipality of the parish of St. Marc de Montreal, in the counties of Maisonneuve and Montreal-Dorion, and the assets and liabilities of the latter shall be merged with the assets and liabilities of the said commission.

**Coming into force.** **3.** This act shall come into force on the day of its sanction.

## C H A P . 4 1

An Act to annex the school municipality of Amherst Park to that of the Catholic School Commission of Montreal.

[Assented to 5th March, 1915]

**Preamble.** **W**HEREAS the school commissioners of the municipality of Amherst Park, in the county of Laval, have, by their petition, represented that it is in the interest of education generally, and of their municipality in particular, that the latter be annexed to that of the Catholic School Commission of Montreal, and it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**Annexation of school municipality.** **1.** The school municipality of Amherst Park, in the county of Laval, is annexed to the school municipality under the jurisdiction and control of the Catholic School Commission of Montreal.

**Rights and obligations transferred.** **2.** From the date of such annexation, the Catholic School Commission of Montreal shall be vested with the
