Annexation of school municipality. **1.** The school municipality of the parish of St. Marc de Montreal, in the counties of Maisonneuve and Montreal-Dorion, is ~~annexed to the~~ school municipality under the jurisdiction and control of the Catholic School Commission of Montreal.

Rights and obligations transferred. **2.** From and after the date of the annexation, the Catholic School Commission of Montreal shall be vested with the rights and subject to the obligations of the school commissioners of the municipality of the parish of St. Marc de Montreal, in the counties of Maisonneuve and Montreal-Dorion, and the assets and liabilities of the latter shall be merged with the assets and liabilities of the said commission.

Coming into force. **3.** This act shall come into force on the day of its sanction.

C H A P . 4 1

An Act to annex the school municipality of Amherst Park to that of the Catholic School Commission of Montreal.

[Assented to 5th March, 1915]

Preamble. **W**HEREAS the school commissioners of the municipality of Amherst Park, in the county of Laval, have, by their petition, represented that it is in the interest of education generally, and of their municipality in particular, that the latter be annexed to that of the Catholic School Commission of Montreal, and it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Annexation of school municipality. **1.** The school municipality of Amherst Park, in the county of Laval, is annexed to the school municipality under the jurisdiction and control of the Catholic School Commission of Montreal.

Rights and obligations transferred. **2.** From the date of such annexation, the Catholic School Commission of Montreal shall be vested with the

rights and subject to the obligations of the school commissioners for the municipality of Amherst Park, in the county of ~~Laval~~, and the assets and liabilities of the latter shall be merged ~~with~~ the assets and liabilities of the said commission.

3. This act shall come into force on the day of its sanction. Coming into force.

C H A P . 4 2

An Act to annex the school municipality of the parish of St-Anselme, in the County of Maisonneuve, to that of the Catholic School Commission of Montreal.

[Assented to 5th March, 1915]

WHEREAS the school commissioners of the school municipality of the parish of St. Anselme, in the county of Maisonneuve, have, by their petition, represented that it is in their interest, in that of education generally, and in that of the Catholic School Commission of Montreal, that their school municipality be annexed to that of the said commission, and whereas it is expedient to grant their prayer: Preamble.

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The school municipality of the parish of St. Anselme, in the county of Maisonneuve, is annexed to the school municipality under the jurisdiction and control of the Catholic School Commission of Montreal. Annexation.

2. From the date of such annexation the Catholic School Commission of Montreal shall be vested with the rights and subject to the obligations of the school commissioners of the municipality of the parish of St. Anselme, in the county of Maisonneuve, and the assets and liabilities of the latter shall be merged with the assets and liabilities of the said commission. Rights and obligations transferred.
