CHAP. 58

An Act to amend the Revised Statutes, 1909, relating to exhibitions of moving pictures.

[Assented to 5th March, 1915]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 3713ⁿ of the Revised Statutes, 1909, as en-^{R. S. 3713ⁿ}, acted by the act 3 George V, chapter 36, section 1, and ^{am.} amended by the act 4 George V, chapter 40, section 6, is again amended by adding thereto, at the end thereof, a new paragraph as follows:

“Before the full commission may consider the appeal thus taken in regard to a film or device, the person taking such appeal must produce a receipt showing that he has paid to the collector of provincial revenue for the district of Montreal, on each film or device as defined by the regulations, an additional fee of one dollar, over and above the fee already paid for the first examination.” ^{Fee to be paid for appeal.}

2. Article 3713^p of the Revised Statutes, 1909, as ^{R. S. 3713^p}, replaced by the act 4 George V, chapter 40, section 3, is ^{am.} amended by replacing the words: “one dollar”, in the sixth line thereof, by the words: “two dollars”.

4. Article 1301a of the Revised Statutes, 1909, as enacted by the act 4 George V, chapter 40, section 8, is amended by inserting therein, after the first paragraph thereof, a new paragraph, as follows:

“The words “temporary moving picture hall” mean, for the purposes of this subsection 12a, a public hall or a theatre in which, not oftener than thirty times in one year, shows or exhibitions of moving pictures, whether accompanied or not by theatrical performances or any other shows, are given for a price of admission charged to the public”.

Article 1301d of the Revised Statutes, 1909, as enacted by the act 3 George V, chapter 36, section 3, and amended by the act 4 George V, chapter 40, section 10, is again amended by inserting therein, after the words: “moving picture hall”, in the second and fourth lines thereof, the words: “or a temporary moving picture hall.”

Article 1302 of the Revised Statutes, 1909, as amended by the acts 3 George V, chapter 36, section 4, 4 George V, chapter 40, section 11, 5 George V, chapter 20, section 15, and 5 George V, chapter 22, section 3, is again amended by inserting therein, after the words: “moving picture halls”, in the sixth line thereof, the words, “or temporary moving picture halls,”.

The tariff of duties on licenses contained in article 1302 of the Revised Statutes, 1909, as amended by the acts 3 George V, chapter 36, section 5, 4 George V, chapter 40, section 12, 5 George V, chapter 20, section 15, and 5 George V, chapter 22, section 4, is again amended by adding thereto, at the end of division XII thereof, a new paragraph, as follows:

License for

“For each license for a temporary moving-picture hall,

provided that the duty shall in no case be more than one temporary hundred dollars or less than twenty dollars, ten cents for ^{hall.} each seat capable of holding one person”.

9. Article 1303 of the Revised Statutes, 1909, as ^{R. S. 1303,} amended by the acts 3 George V, chapter 36, section 6, ^{am.} 4 George V, chapter 40, section 13, and 5 George V, chapter 22, section 5, is again amended by inserting therein, at the end of paragraph 7 thereof, the words: “or temporary moving-picture hall,”.

10. Article 1304 of the Revised Statutes, 1909, as ^{R. S. 1304,} amended by the acts 3 George V, chapter 36, section 7, ^{am.} and 5 George V, chapter 22, section 6, is again amended by inserting therein, after the words: “or of a moving-picture hall,” in the second line thereof, the words: “or of a temporary moving picture hall,”.

CHAP. 59

An Act to amend the Quebec Public Health Act.

[Assented to 5th March, 1915]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 3868 of the Revised Statutes, 1909, is amended ^{R. S. 3868,} by replacing paragraph 1 thereof, by the following: ^{am.}

“1. The words “Superior Board” or “Board of Health” or “Board” mean the Superior Board of Health of the Province of Quebec.”

2. The word “Superior” is inserted before the word “Superior” “Board” each time that the expression “Board of Health” ^{inserted in} occurs in articles 3869, 3870, 3873, 3875, 3876, 3877, ^{various} 3879, 3880, 3881, 3882, 3883, 3889, 3892, 3893, 3894, ^{places in R. S.} 3895, 3902, 3903, 3908, 3909, 3914, 3915, 3916, 3917, 3920, 3923, 3924, 3927, 3928, 3931, 3933, 3934, 2936, 3937, 3938, 3941, 3973, 3974, 3975, 3976, 3977, 3978, 3980, 3981, and in the titles of sections, subsections or divisions of the third chapter of the seventh title of the Revised Statutes, 1909.
