

C H A P . 8 6

An Act to amend the law relating to the municipal organization of the county of Saguenay, and to amend articles 29, 283, 291, 293, 927 and 1081 of the Municipal Code, and article 75 of the Revised Statutes, 1909.

[Assented to 5th March, 1915]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Paragraph 57 of article 75 of the Revised Statutes, 75 R. S. am. 1909, as amended by the act 3 George V, chapter 12, section 1, is again amended by replacing all the words after the word "less", in the first line thereof, by the words: "the municipalities east of the River Betsiamites and the Island of Anticosti."

2. Article 29 of the Municipal Code is amended by 29 Mun. Code, am. adding thereto a new paragraph, as follows:

"Nevertheless, in the county of Saguenay, the parts included in a township are not excepted".

3. Article 283 of the Municipal Code, as contained in 283 Mun. Code, am. article 6075 of the Revised Statutes, 1888, and as amended by the acts 61 Victoria, chapter 50, section 1, and 3 George V, chapter 12, section 2, is further amended by replacing the words: "Aux Outardes", in the seventh line thereof, by the word: "Betsiamites."

4. Article 291 of the Municipal Code as contained in 291 Mun. Code, am. article 6076 of the Revised Statutes, 1888, as amended by the act 3 George V, chapter 12, section 3, is again amended by replacing the words: "Aux Outardes", in paragraph 2 thereof, by the word: "Betsiamites".

5. Article 293 of the Municipal Code, as contained in 293 Mun. Code, am. article 6077 of the Revised Statutes, 1888, as amended by the act 3 George V, chapter 12, section 4, is again amended by replacing the words: "Aux Outardes", in the second line of the second paragraph thereof, by the word: "Betsiamites".

6. Article 927 of the Municipal Code, as enacted by 927 Mun. Code, am. the act 3 George V, chapter 12, section 5, is amended by

replacing the words: "Aux Outardes", in the second line thereof, by the word: "Betsiamites".

7. Article 1081 of the Municipal Code, as contained in article 6225 of the Revised Statutes, 1888, and as amended by the acts 53 Victoria, chapter 2, section 3, 59 Victoria, chapter 6, section 2, and 3 George V, chapter 12, section 6, is again amended by replacing the words: "Aux Outardes", in the second line of the fourth paragraph thereof, by the word: "Betsiamites".

C H A P . 8 7

An Act to amend articles 998 and 999 of the Municipal Code relating to the county of the Magdalen Islands.

[Assented to 5th March, 1915]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 998 of the Municipal Code, as it reads in article 6206 of the Revised Statutes of 1888, and as amended by the act 52 Victoria, chapter 54, section 20, is again amended by adding thereto a new paragraph, as follows:

Sale by auc-
tion.

"In the county of the Magdalen Islands the public notice must set forth that such lands are to be sold at public auction on the first juridical Wednesday of the month of July following."

2. Article 999 of the Municipal Code, as amended by the act 5 George V, chapter 76, section 5, is further amended by adding thereto a new paragraph, as follows:

Publication
of notice.

"Such publications, in the case of lands situated in the county of the Magdalen Islands, must be made during the month of May."

3. This act shall come into force on the day of its sanction.
