

## C H A P . 1 1 0

## An Act respecting the town of Sault-au-Recollet.

[Assented to 5th March, 1915]

## Preamble.

**W**HEREAS the corporation of the town of Sault-au-Recollet has, by its petition, represented that it is necessary to amend its charter, the act 4 George V, chapter 95, so as to grant it more ample powers; that it wishes to continue the construction of its own system of sewerage, to extend its waterworks, to complete the paving and macadamizing of streets and public roads, to open new streets and new public squares, and acquire the necessary land therefor, and, for such purposes, it needs to borrow an amount of three hundred thousand dollars; and furthermore the town has had a plan drawn up by F. C. Laberge, land surveyor, of a certain part of the territory not as yet subdivided in such a way as to agree with the general plan of the territory of the municipality which has been previously ratified by the Legislature; and that it is now necessary to ratify this new plan;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 25 of the act 4 George V, chapter 95, is replaced by the following:

**"25.** The following article is inserted in the Revised Statutes, 1909, for the town, after article 5790:

**"5790a.** The council may acquire, by mutual agreement, or by expropriation, all immoveables or parts of immoveables and servitudes necessary for widening and straightening its main road, as well as the extension within the limits of its territory, of the road called "Montée St. Michel" and the opening of a boulevard along the railway tracks of the tramway company, the whole in accordance with the plan drawn up for such purpose by F. C. Laberge, land-surveyor; it may also, if it deems expedient, acquire

in the same manner the whole of all the immoveables, a portion only whereof will be necessary for the above purposes; and in such case, every excess of ground so acquired may be resold, exchanged or otherwise alienated, either as a whole or in part, by mere resolution of the council, by auction, or by mutual agreement. In order that the municipality may expropriate part of an immovable not

required for the above-mentioned purposes, the consent of the proprietor shall be required.

The extension and widening of the road called "Montée Saint Michel" must be finished by the 1st July, 1915.

Public Park.

The council may, in like manner, and for the purpose of establishing a public park, acquire a strip of land forming part of lot No. 227 of the official plan and book of reference of the parish of Sault-au-Recollet, and described on the plan drawn up to that effect by F. C. Laberge, land-surveyor.

**2.** For the purpose of extinguishing its floating debt, of continuing the construction of its sewerage system, of extending its waterworks, including the canalization of certain natural streams, of extending within the limits of the territory the road called "Montée St. Michel", of opening a boulevard and other public roads, and completing the paving and macadamizing of its streets and public roads, opened and to be opened, of establishing and maintaining public parks, and also of acquiring the land necessary for such undertakings, the council is authorized to borrow an amount of three hundred thousand dollars, upon bonds or debentures, repayable in forty years, and at a rate of interest not exceeding six per cent per annum; and articles 5777, 5778, 5782, 5786, and 5788 of the Revised Statutes, 1919, are expressly declared to not apply to the corporation as regards such loan.

Loan authorized for certain purposes.

**3.** The lots of land known and designated under Nos. 115, 116, 117, 118, 119, 120, 121, 122 and 123 of the official plan and book of reference of the parish of Sault-au-Recollet, may, at the request of the majority in number and value of the owners thereof, and by mere resolution of the council of the said parish, be annexed to the municipality of the said town for all municipal purposes.

Certain territory may be annexed to town.

**4.** The plan made and drawn up by F. C. Laberge, land-surveyor, dated the 27th November, 1914, is declared legal, valid and binding upon the municipality, upon the proprietors interested and upon all other parties; and the provisions of article 5644 of the Revised Statutes, 1909, shall apply to such plan; but such plan shall be carried out only when the council deem it advisable, save as above mentioned regarding the road "Montée St. Michel."

Plan to be binding.

**5.** This act shall come into force on the day of its sanction.
