

The provisions of the charter of the town of St. Johns shall apply to such loan, save that the approval of the electors who are proprietors shall in no case be required." Provisions applicable.

3. The act 40 Victoria, chapter 68, is amended by Id., s. 13a, inserting therein, after section 13 thereof, a new section, enacted. as follows:

"13a. The said Louis Molleur, junior, his heirs and assigns, are authorized to borrow an amount not exceeding one hundred and fifty thousand dollars. Louis Molleur, heirs and assigns, authorized to borrow.

Such loan may be effected by means of bonds, debentures or other securities, payable with or without annuities.

To secure the payment of such bonds, debentures or other securities, the said Louis Molleur, junior, his heirs and assigns, may transfer, before or after the issue thereof to one or more trustees, the whole or such portions of the amount to be received as yearly compensation for the water supply, and, under such transfer, such trustee or trustees shall have all the rights, privileges, hypothecs and actions given the creditors by the deed of transfer. Provision for payment of same.

The said Louis Molleur, junior, his heirs and assigns, may also, as security for the loan, give a hypothec upon the whole or some of the properties known as the water-works of St. Johns, or a pledge on the whole or a part of their moveable property, the whole in accordance with articles 6119a to 6119d of the Revised Statutes, 1909, which are declared to apply to the loan authorized by this section." Security for loan.

4. This act shall come into force on the day of its sanction. Coming into force.

C H A P . 1 2 2

An Act respecting E. & A. Leduc, Limited.

[Assented to 5th March, 1915]

WHEREAS the company E. & A. Leduc, Limited, of Montreal, has, by its petition, represented: Preamble.

That it is incorporated by letters patent of the Province of Quebec, issued under the Quebec Companies' Act;

That the company is authorized by such letters patent to carry on the business of meat packing, and of tallow-rendering in every way; to slaughter and sell cattle, sheep and other animals, and to sell the products of the said

packing and tallow-rendering establishment, and generally to do everything in connection with such trade including the meat trade in the city of Montreal and elsewhere;

That the company carries on the said business on a property bearing the numbers 2230 and 2233 of the official plan and book of reference of the parish of Montreal, and situate at the corner of Green and Ste. Emélie streets in St. Henri ward of the city of Montreal, and that it succeeded the firm of E. & A. Leduc, who carried on the same trade at the same place for over thirty years, having obtained the necessary authorization to that effect from the former city of St. Henri, now part of the city of Montreal;

That the above establishment has always been kept in a sanitary, clean and scientific manner, so as to cause no nuisance, and that the company intends to still further improve its establishment on the most modern and improved systems;

That meat-packing and tallow-rendering includes slaughtering of cattle, swine, sheep, lambs and calves;

That by paragraph 53 of article 300 of the act 62 Victoria, chapter 58 (the charter of the city of Montreal), it is enacted that the city of Montreal shall have the right to regulate or prohibit the establishment, construction and operation of stock-yards, packing-houses rendering establishments, tallow-chandleries and sausage manufactories within the city limits or within a distance of one mile outside the said limits;

That the said corporation of the city of Montreal has allowed the establishment of public abattoirs in the said city, and, by by-law No. 129 regulating the said abattoirs, it is enacted among other things that no person or company shall have the right to slaughter any animal elsewhere than in the public abattoirs; that no fresh meat of any animal mentioned in the said by-law, slaughtered elsewhere than in the said public abattoirs, shall be offered for sale for consumption in the said city;

That the company's establishment constitutes and will constitute an advantage for the city of Montreal and for the Province of Quebec; and be an appreciable benefit to the inhabitants of St. Henri ward;

Whereas the said company has prayed to be authorized to carry on its said trade in the city of Montreal, and it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Company

1. The company E. & A. Leduc, Limited, is hereby

authorized to operate on the property bearing the Nos. 2230 and 2233 of the official plan and book of reference of the parish of Montreal, and situate at the corner of Green and Ste. Emelie streets in the city of Montreal, a meat-packing house and tallow-rendering in every form, including the slaughter of animals; it is also authorized to improve, enlarge and rebuild the said establishment. The plans and the construction of said buildings shall be subject to the approval of the said city.

authorized to carry on meat packing house in city of Montreal.

2. The company shall be subject to all present and future by-laws of the city of Montreal, with the exception of that part of by-law No. 129, mentioned in the preamble to this act, which enacts that no person or company shall slaughter animals in the city of Montreal elsewhere than in the public abattoirs, and that no fresh meat shall be sold in the city of Montreal unless the animal has been slaughtered in the said abattoirs.

Subject to by-laws of city, except part of No. 129.

3. Notwithstanding any provisions contained in the said by-law No. 129, the company shall have power to:

Powers of company.

a. Slaughter cattle, swine, sheep, lambs and calves in the said buildings for the purposes of its trade;

b. Keep, maintain and operate a tallow-chandlery, a sausage factory and a factory for preparing and packing meat;

c. Sell the meat of the said animals so slaughtered in such establishments, and the products so prepared, within the limits of the said city of Montreal and elsewhere;

d. Generally carry on the trade of meat-packing, and tallow-rendering in all its forms.

4. This act shall come into force on the day of its sanction.

CHAP. 123

An Act to amend the charter of the Sherbrooke Loan and Mortgage Company.

[Assented to 5th March, 1915]

WHEREAS the Sherbrooke Loan and Mortgage Company has, by petition, represented that section 9 of its charter 49-50 Victoria, chapter 66, provides amongst other things "the company may act as an agency and trust
