An Act to amend the charter of The Montreal Amateur Athletic Association.

[Assented to 5th March, 1915]

WHEREAS The Montreal Amateur Athletic Association—Preamble.
 tion has by its petition represented that it carries on a work among young men, which is educational, and that it finds it necessary for such purposes to open and equip establishments in different places in the Province, and that its property should be assimilated to that of educational establishments and institutions as regards exemption from taxation for municipal and school purposes, and that consequently it is advisable that the act 44-45 Victoria, chapter 55, as amended by the act 3 Edward VII, chapter 127, should be further amended as hereinafter proposed, and

Whereas it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council, and of the Legislative Assembly of Quebec, enacts as follows:

1. The following section is inserted in the act 3³ Ed. VII, c. Edward VII, chapter 127, after section 2a: 127, am.

“**2b.** The corporation may also found, open and equip, New establishments for the use of its members and for the public, in such places may be opened. in the Province as it may select, establishments where gymnastics, physical culture and all bodily exercises connected therewith will be taught, and literary classes held”.

2. The following section is inserted in the act 44-45⁴⁴⁻⁴⁵ Vict., Victoria, chapter 55, after section 6: c. 55, am.

“**6a.** Notwithstanding all law or by-laws to the con-Exemption trary, the buildings, grounds and other immoveables held, from taxation. occupied and possessed by the corporation for the aforesaid purposes, shall be assimilated to educational establishments and institutions as regards exemption from taxation for municipal and school purposes.

This tax exemption shall not apply to water-taxes, nor Exception. to special taxes for sewers, pavements or sidewalks.

This exemption shall apply only to property situated Limitation.

within the limits of the city of Montreal and of the city of Westmount.

Coming into force. **3.** This act shall come into force on the day of its sanction.

C H A P . 1 4 1

An Act to incorporate the Beth Israel Day Nursery and Infants' Home

[Assented to 5th March, 1915]

Preamble. **W**HEREAS the persons hereinbelow mentioned have, by their petition, represented that they are desirous of constituting themselves and others who may subsequently become members thereof, a corporation for the purpose of establishing in the city of Montreal nurseries for the care, training and elementary education of young children of poor working-women, and also of establishing and maintaining therewith an infants' home for the purpose of procuring a temporary home for the care of infants of all races and creeds without distinction; and whereas they have prayed that for the better attainment of the object above mentioned, they be vested with corporate powers; and whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Cohen, merchant tailor; Fannie Vineberg, wife of Joseph Vineberg, merchant; Mary Fainer, wife of Charles Fainer, manufacturer; Mary Brainin, wife of Reuben Brainin, editor; and the said husbands to authorize their wives for the purposes hereof, all of the city and
