

of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. From and after the date of the passing of this act, the Ministers of ministers of the Salvation Army ordained according to its rites and entitled "Staff Officers", and each of them, shall have right and power to make, perform, and register all acts of civil status, and to keep registers of civil status for the congregations of the Salvation Army of which they respectively have charge; the whole according to the provisions of the Civil Code and of the Code of Civil Procedure in such case provided, and to the same extent as provided by said Codes for other ministers and congregations.

2. No such minister shall be entitled to claim and receive an authenticated register until he shall have deposited with the Prothonotary of the Superior Court of the district wherein he shall be exercising his ministry in this Province, a certificate signed by the chief officer of the Salvation Army for the Province of Quebec to the effect that he is an ordained minister in good standing of the rank of "staff officer", and that he has been duly appointed to the charge of one or more congregations of the said Army.

3. This act shall come into force on the day of its sanction.

CHAP. 147

An Act respecting The Grande Ligne Mission.

[Assented to 5th March, 1915]

WHEREAS The Grande Ligne Mission has by its petition represented that its charter should be amended so as to enlarge the scope of the work of the mission; and it is expedient to grant the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 3 of the act 18 Victoria, chapter 72, as replaced by the act 51-52 Victoria, chapter 59, section 2, is again replaced by the following:

"3. The affairs of the said corporation shall be managed by a board of directors, each of whom shall be a member in good standing of a regularly organized Baptist

Church. The persons who shall be directors of the corporation, the number of directors, their length of service, the number necessary to form a quorum, the powers of the directors and the manner and place (within or without the Province of Quebec) of their election, shall be fixed by

By-laws. by-laws passed at any annual or special meeting of the corporation, by a two-thirds vote of the members of the corporation present at such meeting. The corporation may pass by-laws regulating the management of the affairs of the corporation at any annual or special general meeting of the corporation, by a two-thirds vote of the members of the corporation present at such meeting."

Coming into force. **2.** This act shall come into force on the day of its sanction.

C H A P . 1 4 8

An Act to incorporate the St. Peter and St. Paul Russo-Greek Catholic Orthodox Church of Montreal, Canada.

[Assented to 5th March, 1915]

Preamble.

WHEREAS the Reverend Vladimir Joseph Sakovitch, Ivan Ivanhoff, Gregory Zinkevitch, Efrem Shiloff, and Dmitry Nezvesky, all of the city of Montreal, in the Province of Quebec, have by their petition represented that they are persons of Russian origin, belonging to the Russian Greek Orthodox Church, of which they are adherents; that for the purpose of divine worship according to the tenets of the religion of the said church, it is expedient and in the interests of the petitioners that they should be incorporated in order that the corporation to be formed may, in its own name, acquire and possess property, moveable and immovable, keep acts of civil status, and do all things that may be required in connection with the purposes of its incorporation;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Corporation constituted.

Name.

1. The Reverend Vladimir Joseph Sakovitch, Ivan Ivanhoff, Gregory Zinkevitch, Efrem Shiloff and Dmitry Nezvesky, and all other persons who may become members, are hereby constituted a corporation under the name of "The St. Peter and St. Paul Russo-Greek Catholic Orthodox Church of Montreal, Canada".
