

exist as to the power of the said executors to give effect to the said offer, and

Whereas it is expedient to grant the prayer of the said petitioners;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The said Dame Charlotte Smithers and the Royal Trust Company, and their successors in the trust, as executors of the will of the said late Joseph Bowles Learmont, and on behalf of his heirs and legatees, are hereby authorized to make a gift of the said immoveable property known as "Quebec House" with the gardens, stables and appurtenances thereto belonging, situate and lying in the east end of the town of Westerham, fronting on the main road from Seven Oaks to Godstone in the county of Kent in England, to the Dominion of Canada, or to such trustees and upon such trusts as may be requested or sanctioned by His Excellency the Governor-General in Council.

2. This act shall come into force on the day of its sanction.

C H A P . 1 6 7

An Act to authorize the Bar of the Province of Quebec to admit Georges Archambault among its members, after examination.

[Assented to 5th March, 1915]

WHEREAS Georges Archambault, student at law, of the city and district of Montreal, has by petition represented:

That on the 5th July, 1911, he successfully passed the preliminary examination on letters for admission to study medicine;

That in January, 1912, he successfully passed the preliminary examination on sciences for admission to study law;

That, since that date, he has followed the course of lectures of the faculty of law at Laval University, and has studied under indenture in the office of Mr. C. A. Archambault, advocate, Montreal;

That the preliminary examination on letters, for the

admission to the study of medicine, bears on the same subjects as those of the preliminary examination of the Bar of the Province of Quebec, for admission to study law;

That he wishes to present a bill to the Legislature, permitting the Bar of the Province of Quebec to admit him among its members when he shall have passed the examination for admission to the practice of law;

That on the 1st October, 1914, the General Council of the Bar of the Province of Quebec authorized the presentation of a bill for the aforesaid purposes;

That, since the date of the said authorization, the faculty of law of Laval University at Montreal has awarded him a diploma of Bachelor of Law, on the 10th December, 1914;

Whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Bar authorized to permit Georges Archambault to practise law, after examination.

1. The Bar of the Province of Quebec is authorized to permit Georges Archambault to present himself at the examination for admission to practise law upon his previously producing a diploma of Bachelor of Law, and a certificate of clerkship, and to admit him among its members, immediately after he shall have passed the examination for admission to the practice of law.

Coming into force.

2. This act shall come into force on the day of its sanction.

C H A P . 1 6 8

An Act to authorize the Bar of the Province of Quebec to admit Ralph Erskine Allan among its members, after examination.

[Assented to 5th March, 1915]

Preamble.

WHEREAS Ralph Erskine Allan, of the City of Montreal, student at law, has, by his petition, represented:

That in the month of January, 1910, he successfully passed the "sciences" examination; being one part of the required examination for admission to study law;

That on the 1st day of October, 1911, he entered McGill University, Montreal, and there followed the regular course of law, extending over a period of three years, successfully passing all the University examinations;
