

admission to the study of medicine, bears on the same subjects as those of the preliminary examination of the Bar of the Province of Quebec, for admission to study law;

That he wishes to present a bill to the Legislature, permitting the Bar of the Province of Quebec to admit him among its members when he shall have passed the examination for admission to the practice of law;

That on the 1st October, 1914, the General Council of the Bar of the Province of Quebec authorized the presentation of a bill for the aforesaid purposes;

That, since the date of the said authorization, the faculty of law of Laval University at Montreal has awarded him a diploma of Bachelor of Law, on the 10th December, 1914;

Whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Bar authorized to permit Georges Archambault to practise law, after examination.

1. The Bar of the Province of Quebec is authorized to permit Georges Archambault to present himself at the examination for admission to practise law upon his previously producing a diploma of Bachelor of Law, and a certificate of clerkship, and to admit him among its members, immediately after he shall have passed the examination for admission to the practice of law.

Coming into force.

2. This act shall come into force on the day of its sanction.

C H A P . 1 6 8

An Act to authorize the Bar of the Province of Quebec to admit Ralph Erskine Allan among its members, after examination.

[Assented to 5th March, 1915]

Preamble.

WHEREAS Ralph Erskine Allan, of the City of Montreal, student at law, has, by his petition, represented:

That in the month of January, 1910, he successfully passed the "sciences" examination; being one part of the required examination for admission to study law;

That on the 1st day of October, 1911, he entered McGill University, Montreal, and there followed the regular course of law, extending over a period of three years, successfully passing all the University examinations;

That on the 3rd day of November, 1911, he was indentured to Mr. J. N. Greenshields, K.C., of Montreal, by Deed of Indenture passed before F. E. McKenna, N.P., and regularly attended his office as a law student until this date;

That for reasons beyond his control he has been unable to take the part of the required examination for admission to study law, known as the "letters" examination;

That the General Council of the Bar of the Province of Quebec, on the 22nd day of December, 1914, approved of the passing of an act authorizing the Bar of the Province of Quebec to admit the petitioner among its members notwithstanding the fact of his not having passed the "letters" examination;

Whereas the petitioner has prayed that an act be passed for the above purposes, and it is expedient to grant the prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is authorized to admit the said Ralph Erskine Allan to the final examination required for admission to the practice of law, and after such examination, to admit him among the members of the Bar of this Province.

2. This act shall come into force on the day of its sanction.

C H A P . 1 6 9

An Act to authorize the Bar of the Province of Quebec to admit Victor Edouard Béique among its members.

[Assented to 5th March, 1915]

WHEREAS Victor Edouard Béique, of the city of Montreal, has, by his petition, represented:

That he followed a complete course of classical studies at St. Mary's college, Montreal;

That he obtained the degree of Bachelor of Letters, and afterwards his matriculation in sciences;

That, owing to a clerical error in the diploma, he was unable to obtain it for some years;

That he has, since then, obtained his diploma corrected,
