CHAP. 175

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Georges Dumont among its members.

[Assented to 5th March, 1915]

WHEREAS Georges Dumont of the city and district of Preamble.

Montreal, student, has, by his petition, represented:

That in October, 1910, he was matriculated as a student of the school of dental surgery of Laval University, in Montreal;

That he followed the course of lectures of that school for the four regulation university years;

That in the month of April, 1914, he passed his university examinations in the presence of the assessors representing the College of Dental Surgeons of the Province of Quebec, and was awarded the degree of Doctor of Dental Surgery;

That, owing to circumstances beyond his control, he was unable to present himself at the examinations for admission to the study of dental surgery, before entering the school of dental surgery of Laval University in Montreal;

That in the month of September, 1913, he presented himself before the board of examiners of the College of Dental Surgery of the Province of Quebec, and passed the examination for admission to the study of dental surgery;

That, owing to his studies and experience and his qualifications as above stated, he possesses the knowledge and titles required for a practising dentist;

That the board of governors of the College of Dental Surgeons of the Province of Quebec, has approved the passing of an act to authorize the College of Dental Surgeons of the Province of Quebec to admit the petitioner among its members without further examination, from the date of the sanction of this act;

Whereas the petitioner has, by his petition, prayed that an act be passed to that effect, and it is expedient to grant his prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Georges Dumont among its members, and to grant him the necessary license for the practice of dental surgery in this Province.

CHAP. 176

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Wilfrid Leahy, among its members.

[Assented to 5th March, 1915]

Preamble.

WHEREAS Wilfrid Leahy, of the city and district of Montreal, has, by his petition, represented:

That he obtained his degree of doctor of Dental Surgery at the Baltimore College of Dental Surgery, at Baltimore, in the State of Maryland, one of the United States of America, in 1909;

That since 1910 he has acted as assistant to a licensed dentist in Montreal, in this Province;

That in the month of September, 1914, he successfully passed, before the examiners appointed for the purpose by the board of governors of the College of Dental Surgeons of the Province of Quebec, the examination required by the latter for admission to the study of dentistry in this Province;

That in view of his studies, his qualifications and studentship, the board of governors of the Dental College of the Province of Quebec has consented to the passing of an act authorizing the said college to grant him a license to practise his profession after examination;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
