#### CHAP. 64

An Act to amend the Civil Code relating to privileges of certain workmen on moveable property.

[Assented to 19th February, 1914]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

. **1.** The Civil Code is amended by inserting therein, C. C. 1994*d*, after article 1994*c*, as enacted by the act 57 Victoria enacted. chapter 47, section 1, and amended by the act 62 Victoria chapter 50, section 1, a new article, as follows:

"**1994*d*.** Workmen who have worked for persons giving Privilege for theatrical or other profit-making exhibitions, including workmen who have

circuses, shall have a privilege upon things used for the purposes of such exhibitions above-mentioned, and which belong to such persons, for thirty days salary due and unpaid."

**2.** Article 2001 of the Civil Code, as replaced by the act 60 Victoria, chapter 50, section 34, is amended by inserting therein, after the words: "Workmen upon things repaired by them, and persons having a privilege in virtue of article 1994c", in the eleventh and twelfth lines thereof, the words: "or 1994d".

## C H A P. 65

An Act to declare legal certain registrations in the Registry office of the County of Gaspé.

[Assented to 19th February, 1914]

Preamble.

**W**HEREAS the Registrar of the registration division of Gaspé, at Percé, has had the index to the immoveables for the township of Pabos used in that registration division since the 16th of November, 1905, the date at which the cadastre came into force, paged, paraphed and authenticated as required by articles 2181 and 2182 of the Civil Code, which had been omitted at the date mentioned; and

Whereas it is expedient that the registrations and entries made or to be made in the said index, be made legal;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** All the registrations or entries made or to be made hereafter in the index of immoveables of the township of Pabos, of the registration division of Gaspé, at Percé, now paged, paraphed and authenticated by the Prothonotary of the Superior Court of the district of Gaspé, are and shall be as valid as if such index had been so paged, paraphed and authenticated before being used.

**2.** Nothing in this act shall affect cases pending before any court, in which the validity of the said registrations is in question.
