**3.** By-law No. 25 of the town of Montreal East, concerning certain annexations to the territory, is hereby authorized, ratified, confirmed and declared valid, to all intents and purposes.

**4.** Every expropriation which the town is authorized to make shall be governed, *mutatis mutandis*, by the provisions of the Quebec Railway Act, as amended by the act 3 George V, chapter 42, (articles 6565-6596 inclusively, R. S. 1909).

**5.** In the place and stead of the valuation role for the year 1914, the town is authorized to make, immediately after the sanction of this act, and observing the usual delays and formalities, *mutatis mutandis*, for its whole territory as defined by this act, a new valuation roll, which shall remain in force until the coming into force of the valuation roll of 1915.

**6.** The first general election shall be held on the first juridical day of February, 1915, and the mayor and aldermen at present in office shall continue in office till such date.

**7.** This act shall come into force on the day of its sanction.

## CHAP. 89

An Act to amend the charter of the town of La Pointe aux Trembles.

[Assented to 19th February, 1914]

Preamble.

**W**HEREAS the corporation of the town of La Pointe aux Trembles, has, by its petition, represented that its charter, the act 2 George V, chapter 74, as amended, does not sufficiently meet the growing needs of the said

municipality; that it is necessary to give it more ample powers, and in particular, power to borrow a sum of three hundred thousand dollars to extinguish its floating debt, complete its sewerage system, macadamize its streets, and make permanent sidewalks, as well as to widen certain streets, and it is moreover expedient to ratify certain by-laws and certain transactions and to amend certain provisions of the Cities' and Towns' Act, with respect to it;

And whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The council of the town of La Pointe aux Trembles is authorized to borrow an amount of three hundred thousand dollars on bonds or debentures, redeemable in forty years, for the purpose of extinguishing its floating debt, completing its sewerage system, macadamizing its streets, and making permanent sidewalks, as well as widening Notre Dame, St. Jean Baptiste and other streets within the limits of the town. Loan authorized.

**2.** By-law No. 30, enacting the aforesaid loan, passed by the council on the 11th November, 1913, is, notwithstanding all laws to the contrary, ratified and confirmed in its form and tenure; and articles 5777, 5778, 5782, 5783, 5786 and 5788 of the Revised Statutes, 1909, are expressly declared not to apply to the town as regards such loan and such by-law. By-law ratified. Certain articles not to apply.

**3.** The council of the town of La Pointe aux Trembles is authorized to pay interest, not exceeding six per cent per annum, upon all loans to be effected. Int. not to exceed six per cent.

**4.** Article 5903 of the Revised Statutes, 1909, is replaced, for the town, by the following: 5903 R.S. replaced for the town.

**"5903.** Every debenture issued by the town shall be valid and recoverable in full, although it may have been negotiated at a rate below par, or at a rate of interest exceeding six per cent per annum, and cannot be invalidated in the hands of a holder in good faith for value."  
Debentures valid as regards holder in good faith for value.

**5.** Article 5557 of the Revised Statutes, 1909, is replaced, for the town, by the following: 5557 R.S. replaced for the town.

**"5557.** Unless it be otherwise ordered by by-law, the council shall meet at least once a week, on Tuesday evening, in general or ordinary session, for the transaction Council to meet once a week.

**6.** Notwithstanding any law to the contrary, the town is authorized to make with *l'Association de l'Exposition Industrielle de Montréal*, or any other corporation or public body, association or persons working for the organization of an industrial or other exhibition, all arrangements which may be deemed suitable for the purpose of helping them to establish and hold such exhibition within the limits of the town; it is also authorized to make arrangements, contracts and agreements with the municipality of the parish of La Pointe aux Trembles, in connection with the same.

**7.** The negotiation of the one hundred and twenty bonds or debentures of the corporation amounting to one thousand dollars each, between the council of the town of La Pointe aux Trembles and The Canadian Order of Foresters, is declared valid and legal and ratified and confirmed.

**8.** By-law No. 26 adopted by the council of the town of Pointe-aux-Trembles on 7th January, 1914, annexing part of the territory of the parish of La Pointe-aux-Trembles to the town of La Pointe aux Trembles, is declared legal and valid, and shall have full and entire effect notwithstanding any law or provision to the contrary.

**9.** The resolution adopted by the council on the 7th January, 1914, purporting to free a certain immoveable belonging to Mr. Jean Versailles from the hypothec thereon in favor of the town, is declared valid and legal, and is ratified and confirmed; provided however that it be approved of by proprietors electors of the town of La Pointe aux Trembles in accordance with the provisions of articles 5609 to 5622 inclusively of the Revised Statutes, 1909.

**10.** This act shall come into force on the day of its sanction.
