

5. In future, no factory, mill or workshop whatsoever shall be built on the Grand Boulevard from the eastern boundary of the parish of Rivière des Prairies to the western line of the municipality of the village of St. Michel de Laval. Wood-yards, coal-yards and the erection of ice houses thereon are also forbidden. Dwellings, shops and business houses shall be at a uniform distance of fifteen feet from the homologated lines of the said boulevard, shall be at least two stories high, and be built of stone or brick, or of wood faced with stone or brick. Building restrictions.

6. Notwithstanding any law to the contrary, the council of any interested municipality is, for the purposes mentioned in this act, authorized to effect loans by means of issues of bonds or debentures of such municipality by-law to that effect adopted by the said council and approved by the Lieutenant-Governor in Council. Special borrowing powers to interested municipalities.

7. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 101

An Act to amend the charter of the Quebec Central Railway Company.

[Assented to 19th February, 1914]

WHEREAS the Quebec Central Railway Company has by its petition represented that the said company, as authorized by the act 2 George V, chapter 82, section 5, has established the head office of the company at the city of Montreal ; Preamble.

That certain doubts have arisen as to whether meetings of the shareholders and directors of the company should be held at the head office in the city of Montreal or elsewhere ;

That it is advisable to determine where such meetings shall be held ;

That it is advisable that certain disqualifications from the office of directors should be removed in the case of the said company ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Section 8 of the act 62 Victoria, chapter 74, amending section 8 of the act 49-50 Victoria, chapter 82, and section 10 Provisions repealed.

of the said act 62 Victoria, chapter 74, amending section 9 of the act 49-50 Victoria, chapter 82, are hereby repealed.

Where meetings to be held.

2. Notwithstanding any law or by-law to the contrary, the annual general meeting and all special general meetings of the shareholders, and all meetings of the board of directors of the said company, shall be held in the city of Montreal in the Province of Quebec, or elsewhere in the said Province, as may be by by-law from time to time fixed by the board of directors. The time and place of such meetings shall, in like manner, be determined by the said board.

R. S. 6488 replaced for the company.

3. Article 6488 of the Revised Statutes, 1909, is replaced, for the company, by the following :

Who may be directors.

“ 6488. The general manager of the said company or any officer thereof may legally act as a director of the said company, but no person being concerned or interested in any contract under or with the company shall be capable of being chosen a director or of holding the office of director, nor shall any director of the company enter into, or be directly or indirectly, for his own use and benefit, interested in any contract with the company, not relating to the purchase of land necessary for the railway, or be or become a partner of any contractor with the company ”.

Coming into force.

4. This act shall come into force on the day of its sanction.

CHAP. 102

An Act to incorporate the “Three Rivers Traction Company”.

[Assented to 19th February, 1914]

Preamble.

WHEREAS by their petition the persons hereinafter mentioned have represented:

That it is in the interest of the city of Three Rivers and of the counties of St. Maurice, Maskinongé and Champlain that a railway be built and operated in order to bring the various towns, villages and parishes of the said counties into communication with one another, and with the city of Three Rivers, and also to establish a system of tramways in the said city of Three Rivers; and have by their petition prayed for the passing of an act incorporating them under the name of the “Three
