

## C H A P. 119

## An Act to incorporate "The Presentation Brothers of Ireland".

[Assented to 19th February, 1914]

Preamble.

**W**HEREAS Reverend Brothers Thomas Aloysius Rahilly, Eugene Ignatius Connolly, Michael Stanislaus Kennealy, Nicholas Benignus Liston, Aeneas Peter Curtin, Patrick Cassian Cagney, Patrick Berchmans Boyce, John Wenceslaus Whelan, and Nicholas O'Sullivan, have by their petition represented:

That they are desirous of constituting themselves a religious corporation under the name of "The Presentation Brothers of Ireland";

That the purpose of petitioners in soliciting the act of incorporation, is to have the power and the right to establish and conduct schools in the Province of Quebec and to teach in said schools, the seat of said corporate body to be in the city and district of Montreal;

That the following powers would also be conducive to the attainment of the objects of petitioners, namely:

*a.* The power and the right to acquire property, moveable and immoveable, in the Province, and to buy and sell the same;

*b.* The power to receive donations and bequests of whatsoever nature, with the right to expend the same for educational purposes as may seem proper to them;

*c.* The power and the right to become affiliated with a chartered university in the Province, and to make arrangements with any board of school commissioners or school trustees for the purpose of conducting and equipping schools, and all other powers ancillary to those above mentioned and to the objects above described;

*d.* The power of building and maintaining a novitiate and training college for the education of members of their community for the diffusion of education in Canada, with power to enter into contracts for the achievement of this purpose, and with all other powers incidental thereto;

And whereas it is in the interests of the said petitioners that all said powers be granted and that they become a body corporate, and a religious community, under the name of "The Presentation Brothers of Ireland";

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Reverend Brothers Thomas Aloysius Rahilly, Eugene Ignatius Connolly, Michael Stanislaus Kennealy, Nicholas Benignus Liston, Aeneas Peter Curtin, Patrick Cassian Cagney, Patrick Berchmans Boyce, John Wenceslaus Whelan, and Nicholas O'Sullivan are hereby constituted a corporate body and a religious community to be known as "The Presentation Brothers of Ireland", the seat of the said corporate body to be in the city and district of Montreal.

**2.** The said corporate body and religious community shall have the power and the right to establish and conduct schools in the province of Quebec, and to teach in said schools.

**3.** The said corporation and religious community shall have the following powers and rights, namely:

a. The power and the right to acquire property, moveable and immoveable, in the Province, and to buy and sell the same; but the yearly revenue from such immoveables shall not exceed the sum of ten thousand dollars;

b. The power to receive donations and bequests of whatsoever nature, with the right to expend the same for educational purposes as may seem proper to said corporate body;

c. The power and the right to become affiliated with a chartered university in the Province, and to make arrangements with any board of school commissioners or school trustees for the purpose of conducting and equipping schools;

d. All other powers ancillary to those above mentioned and to the objects above described;

e. The power of building and maintaining a novitiate and training college for the education of members of their community, for the diffusion of education in the province of Quebec, with power to enter into contracts for the achievement of this purpose, and with all other powers incidental thereto.

**4.** The said corporate body shall have the power to do all such things as are requisite for the carrying out of the objects of the said incorporation.

**5.** The corporation shall transmit to the Lieutenant-Governor in Council whenever thereunto required by the Provincial Secretary, a detailed statement of its moveables

and immoveables, the names of its officers and a copy of its rules and by-laws.

Coming into force. **6.** This act shall come into force on the day of its sanction.

## C H A P. 120

An Act to amend the act to incorporate the Association of Opticians of the Province of Quebec and to change its name to that of "the Association of Optometrists and Opticians of the Province of Quebec".

[Assented to 19th February, 1914]

Preamble. **W**HEREAS the Association of Opticians of the Province of Quebec, incorporated by the acts 6 Edward VII, chapter 89, 9 Edward VII, chapter 130 and 2 George V, chapter 110, has, by its petition, represented that it is in the interest of the proper administration of the association and of the public that certain additional powers pertaining to its working be granted it and that its name be changed as hereinafter mentioned;

Whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Change of name. **1.** The name of the Association of Opticians of the Province of Quebec is changed to that of "The Association of Optometrists and Opticians of the Province of Quebec."

Not to affect rights and liabilities. Such change of name shall not affect the rights and liabilities of the association, and all actions or proceedings that could have been taken against or by the association under its former name, may be taken or continued against or by it under its new name.

6 Ed. VII, c. 89, s. 5, replaced. **2.** Section 5 of the act 6 Edward VII, chapter 89, is replaced by the following:

Special and general meetings. **"5.** It shall be lawful for the members of the corporation to have general meetings once a year, and also special general meetings as the council may deem advisable from time to time. The annual general meetings shall take place in the city of Montreal or in any other city on the first Monday in May of each year or the
