

## C H A P. 149

An Act to incorporate "The Lakeview Cemetery Company"

[Assented to 19th February, 1914]

Preamble.

**W**HEREAS a petition has been presented by Reverend Richard Hewton, rector of St. Paul's Anglican Church; Reverend George McKinnon, pastor of St. Andrew's Presbyterian Church; Reverend Austin Ireland, rector of St. Stephen's Anglican Church; Reverend Johnson Seller, pastor of the Lachine Methodist Church; Charles Watt, gentleman, all of the city of Lachine in the district of Montreal, and John McCormack, agent, of the city and district of Montreal; representing that a large number of persons of the Protestant faith are living in the city of Lachine and vicinity; that the Protestant cemetery at Lachine is completely taken up; that the only other cemeteries for persons belonging to the Protestant faith, in the district of Montreal, are situate at Mount-Royal and at Pointe-aux-Trembles, a long distance from the city of Lachine; and

Whereas the said petitioners have prayed to be incorporated under the name of "The Lakeview Cemetery Company"; and

Whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Corporation constituted.

**1.** Reverend Richard Hewton, rector of St. Paul's Anglican Church; Reverend George McKinnon, pastor of St. Andrew's Presbyterian Church; Reverend Austin Ireland, rector of St. Stephen's Anglican Church; Reverend Johnson Seller, pastor of the Lachine Methodist Church; Charles Watt, gentleman, all of the city of Lachine, in the district of Montreal, and John McCormack, agent, of the city and district of Montreal, and all persons who may hereafter become members of the said corporation, are hereby constituted a corporation under the name of "The Lakeview Cemetery Company".

**2.** The said corporation may acquire, on such terms as its board of management may see fit, a tract of land known and designated as cadastral lot No. 34 in the parish of Pointe-Claire, in the district of Montreal, the same to be used as a cemetery.

Subject to

**3.** The corporation shall be subject to all the laws of

this Province relating to the establishment and maintenance of cemeteries, interments and disinterments, except in so far as they are inconsistent with this act. laws re cemeteries.

**4.** The head office of the corporation shall be in the district of Montreal, at such place as the board of directors may determine. Head office.

**5.** The corporation may have, hold and possess, and may acquire by purchase, gift, will or otherwise, any moveable or other immoveable property in the district of Montreal that may be required for the purposes for which the corporation is created; provided always that the use of any lands for a cemetery shall be subject to the laws respecting cemeteries, and provided further that such other immoveable property shall not exceed in annual value the sum of twenty-five thousand dollars. May acquire property on certain conditions.

The corporation shall not establish a cemetery within the limits of the city of Montreal and the town of Outremont.

**6.** Any person subscribing at least one share of ten dollars shall be entitled to become a member of the corporation. Subscribers to be members.

**7.** The corporation is hereby empowered to establish, own and maintain a cemetery on the property hereinabove mentioned; to lay out, improve, plant and embellish the same; to erect and maintain gardens and green-houses for that purpose, and to provide convenient roads thereon. Cemetery to be established, &c.

**8.** The corporation is hereby authorized to commence its operations as soon as they have acquired said cadastral lot No. 34 of the parish of Pointe-Claire. and as soon as such site shall have been approved by the Board of Health of the Province of Quebec, in accordance with article 4423 of the Revised Statutes, 1909. Commencement of operations.

**9.** The affairs of the corporation shall be administered by a board of directors composed of not more than fifteen members of the corporation. Board of management.

**10.** The rector of St. Paul's Anglican Church, the pastor of St. Andrew's Presbyterian Church, the rector of St. Stephens Anglican Church, and the pastor of the Lachine Methodist Church, all of Lachine, and a member of each of their respective congregations, and each by such congregation elected, and who shall be a member of the corporation created by this act, shall ex-officio form part of the said board of directors. Certain ex officio members.

By-laws.

**11.** The corporation shall have the right to pass by-laws not inconsistent with this act or the laws of this Province, necessary or convenient for the carrying out of the objects for which the corporation is created, and the carrying out and the enforcing of such by-laws shall be vested in the said board of directors.

Endowment fund.

**12.** The directors shall be bound to set aside each year out of the receipts of the corporation a sum of money which shall form an endowment fund for the maintenance of the cemetery.

By-laws re regulation of cemetery.

**13.** The corporation may pass by-laws for the laying out, selling, leasing and managing of the ground, for the regulating of burials to be made therein, the erection or removal of tombs, monuments, grave-stones, vaults, copings, fences, hedges or other permanent improvements therein, the planting, placing and removal of trees, shrubs and plants in the ground, and otherwise generally respecting the use of the grounds by the public; and to execute conveyances or leases of plots in the cemetery.

Certain articles of R.S. to apply.

**14.** The corporation shall enjoy all the powers and privileges of corporations in general, and shall be subject to articles 5958 to 6001, both inclusive, of the Revised Statutes, 1909, in so far as they are not inconsistent with this act.

Statement to be transmitted when required.

**15.** The corporation shall transmit to the Lieutenant-Governor in Council whenever thereunto required by the Provincial Secretary, a detailed statement of its moveables and immoveables, the names of its officers and a copy of its rules and by-laws.

Coming into force.

**16.** This act shall come into force on the day of its sanction.
