thenticated according to the laws of this Province, of all births, marriages and burials performed by or taking place under the ministry of such pastor, minister or missionary, and such acts of civil status and the registration thereof have had and shall have the same effect at law to all intents and purposes as those performed and kept by any minister in the Province of Quebec of the churches of England or Scotland, and this notwithstanding the failure of any such pastor, minister or missionary to take the oath of allegiance or to give security as provided under the acts of the Legislature of the Province of Lower Canada, 3 William IV, chapter 29, and 6 William IV, chapter 49, and notwithstanding the fact that any such pastor, minister or missionary may not be, or may not have been a British subject, and notwithstanding that the registration of any such births may not have been accompanied by baptism.

Must depo-
sit certificate.

2. Provided always that no such pastor, minister or missionary shall be entitled to claim and receive an authenticated register until he shall have deposited with the prothonotary of the Superior Court in the district where he shall be exercising his ministry in this Province, a certificate signed by the moderator or secretary of the association of Baptist churches within the bounds of which association his church or churches may be situated, to the effect that he is an ordained pastor, minister or missionary in good standing, and that he has been duly appointed to be the pastor, minister or missionary of one or more Baptist churches.

Coming into
force.

3. This act shall come into force on the day of its sanction.

C H A P. 157

An Act to incorporate the "Hebrew Children's fresh air fund of Montreal".

[Assented to 19th *Fébruary*, 1914]

Preamble.

WHEREAS David Hillel Bernstein, Samuel Ortenberg and Charles Joseph Gross, physicians; Hyman Schleifer, George Rabinovitch, Jacob Besner, Michael Flanders, H. M. Levinoff, Samuel Rabinovitch, Max Rabinovitch and Julius Nathan Newman, agents; Samuel Bazar, Moses Zelicovitch, Isaac Cohen, Julius Gittleson and Abraham L. Gittleson, merchants; Rubin Brainin, editor, and Hyman Wolofsky, publisher; all of the city and

district of Montreal; have by their petition represented that they are desirous of constituting themselves, and others who may subsequently become members thereof, into a corporation for the purpose of maintaining a home in a country district in the Province of Quebec to which children can be sent during the summer season for recuperation, and maintaining an hospital and convalescent home for adults;

Whereas the said petitioners have prayed that they be incorporated as a corporation under the name of the "Hebrew Children's fresh air fund of Montreal", for the purposes above mentioned, and it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Gittleston, Rubin Brainin and Hyman Wolofsky; all of the city and district of Montreal, and all other persons who may hereafter become members of such corporation, are hereby incorporated and created a corporation under the name of the "Hebrew Children's Name. fresh air fund of Montreal".

2. The head office of the said corporation shall be in Head office.
the city of Montreal, in the Province of Quebec.

3. The object for which such corporation is created is Object.
to maintain a home in a country district in the Province of Quebec to which children can be sent during the summer season for recuperation, and to maintain an hospital and convalescent home for adults.

4. The corporation shall have perpetual succession Powers.
and a common seal which it may alter at will, may sue and be sued, borrow, sign bills of exchange and promissory notes, hold, accept and acquire by any legal title moveable or immoveable property which it may sell, convey, lease, transfer or exchange or otherwise dispose of by any title whatsoever, and hypothecate its immoveables; provided, however, that the annual value of the immoveable property possessed by the corporation for the purpose of revenue only, shall not at any time exceed the sum of twenty-five thousand dollars; make, amend and repeal regulations

and by-laws not contrary to law which it may deem essential and necessary for its interests and government; the present by-laws of the association in so far as they are consonant with the spirit of the act, shall remain in force unless or until so amended or repealed; shall have the power to make arrangements with any other similar societies, hospitals or corporations for the acquisition thereof or the amalgamation therewith under the name of the corporation hereby created, provided that such terms or conditions shall not change or modify in any respect the constitution of the corporation hereby created; and upon completion of such amalgamation the amalgamated societies, hospitals or corporations shall be governed by the provisions of this act.

Certain laws
to apply.

5. Nothing in this act shall authorize the corporation to escape municipal laws, or by-laws, or the laws respecting health.

Statement to
be made

6. The corporation shall transmit to the Lieutenant-Governor in Council, when thereto required, a statement of the property it possesses, the names of its officers, and a copy of its rules and regulations.

Coming into
force.

7. This act shall come into force on the day of its sanction.

CHAP. 158

An Act to incorporate the Rossland Jewish Synagogue.

[Assented to 19th February, 1914]

Preamble.

WHEREAS Isaac Malkevitch, coppersmith; Harry Zeltzer, cutter; Kievsky Tavaznansky, trader; Hyman Tabatchnikoff, carpenter contractor; Harry Weiss, tailor; Joseph Levinson, presser; Joseph Leiferman, grocer; Herzl Greenshpan, milkman, all of the city and district of Montreal, have by petition represented that they are persons professing the Jewish religion, and have prayed to be incorporated as a religious congregation for the purpose of divine worship in the city of Montreal, under the name of the "Rossland Jewish Synagogue;"

And whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
