C H A P. 168

An Act to authorize the Bar of the Province of Quebec to admit Henri Etienne Joseph Vautelet to the study of law.

[Assented to 19th February, 1914]

Preamble.

WHEREAS Henri Etienne Joseph Vautelet, of the city of Montreal, has, by his petition, represented:

That he followed a complete course of studies at the High School of Montreal, where he followed a preliminary classical course for seven years and a course in classics and sciences for four years;

That in the month of June, 1910, he obtained a certificate from the said High School of Montreal that he had successfully passed the final year examinations in the course of classics and sciences;

That he followed a complete course at the Royal Military College of Canada at Kingston, in the Province of Ontario, and obtained a graduates' diploma from the said institution on the 18th June, 1913.

That the Royal Military College of Canada is an institution for the whole of Canada, having been founded by a special act of the Federal Parliament;

That in the Province of Ontario the holder of a diploma, from the Royal Military College of Canada is admitted to the study of law like any graduate of a Faculty of Arts;

That he wishes the said diploma from the Royal Military College of Canada to be assimilated to the diploma of Bachelor of Letters, of Sciences or of Arts conferred by any Canadian or British university, and that, consequently, he be dispensed, as regards admission to the study of law, from the examinations required by the act incorporating the members of the legal profession;

That on the 22nd September, 1913, the members of the Council of the Bar of Montreal adopted a resolution recommending the General Council of the Bar of the Province of Quebec to approve the said application;

That the General Council of the Bar of the Province of Quebec has approved the petitioner's request, and consents to his petition being granted;

Whereas the petitioner prays that an act be passed for the above purposes, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is hereby authorized to admit the said Henri Etienne Joseph Vautelet to the study of law without examination, and on the mere production of the diploma given him by the Royal Military College of Canada. Bar authorized to admit H. E. J. Vautelet to study law.

2. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 169

An Act to authorize the Bar of the Province of Quebec to permit Daniel Percy Gillmor to practise law.

[Assented to 19th February, 1914]

WHEREAS Daniel Percy Gillmor, of the city of Montreal, has by his petition represented:

That he entered the faculty of law of McGill University in the month of September, 1910, and received his degree of Bachelor of Civil Law in the month of May, 1913, having followed the lectures given in the faculty of law till that date since the month of September, 1910;

That while taking his first year in the faculty of law he completed his final year in the faculty of arts in McGill University, and received his degree of Bachelor of Arts in the month of May, 1911;

That he presented himself before the examiners of the Bar of the Province of Quebec, and was duly admitted to study on the 6th day of July, 1911;

That he had previously been indentured as a student-at-law to Albert J. Brown, K. C., in the month of December, 1910, and has pursued his indentures ever since the said date;

That he presented himself before the examiners of the Bar of the Province of Quebec and passed the examinations for admission to practise in the month of July, 1913;

That he has completed all the studies and requirements for admission to practise law with the exception of following
