

That the General Council of the Bar of the Province of Quebec has approved the petitioner's request, and consents to his petition being granted;

Whereas the petitioner prays that an act be passed for the above purposes, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is hereby authorized to admit the said Henri Etienne Joseph Vautelet to the study of law without examination, and on the mere production of the diploma given him by the Royal Military College of Canada.

Bar authorized to admit H. E. J. Vautelet to study law.

2. This act shall come into force on the day of its sanction.

CHAP. 169

An Act to authorize the Bar of the Province of Quebec to permit Daniel Percy Gillmor to practise law.

[Assented to 19th February, 1914]

WHEREAS Daniel Percy Gillmor, of the city of Montreal, has by his petition represented:

That he entered the faculty of law of McGill University in the month of September, 1910, and received his degree of Bachelor of Civil Law in the month of May, 1913, having followed the lectures given in the faculty of law till that date since the month of September, 1910;

That while taking his first year in the faculty of law he completed his final year in the faculty of arts in McGill University, and received his degree of Bachelor of Arts in the month of May, 1911;

That he presented himself before the examiners of the Bar of the Province of Quebec, and was duly admitted to study on the 6th day of July, 1911;

That he had previously been indentured as a student-at-law to Albert J. Brown, K. C., in the month of December, 1910, and has pursued his indentures ever since the said date;

That he presented himself before the examiners of the Bar of the Province of Quebec and passed the examinations for admission to practise in the month of July, 1913;

That he has completed all the studies and requirements for admission to practise law with the exception of following

his indentures for the required three years since his admission to study;

That the council of the Bar of Montreal and the general council of the Bar of the Province of Quebec have approved petitions setting forth the provisions of this act;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Bar authorized to permit D. P. Gillmor to practise law.

1. The Bar of the Province of Quebec is hereby authorized to permit the said Daniel Percy Gillmor to practise law.

Coming into force.

2. This act shall come into force on the day of its sanction.

C H A P. 170

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Alonzo Wright McClelland among its members after examination.

[Assented to 19th February, 1914]

Preamble.

WHEREAS Alonzo Wright McClelland of the city and district of Montreal, student, has by petition represented:

That he has followed a course of studies in the Granby Academy and obtained the standing of "Associate in Arts" from the Department of Public Instruction at Quebec after passing the leaving examinations in the said institution, but that owing to circumstances beyond his control, he did not present himself for the examination for admission to study Dental-Surgery before entering the school of dental surgery of McGill University at Montreal;

That since the 3rd of October, 1910, he has followed the lectures and clinics of the said school of dental surgery of McGill University;

That he is now a student in the said school of dental surgery of McGill University and will have completed the four yearly sessions of the said school in the spring of 1914, and will then have followed all the courses of lectures and clinics prescribed by the board of governors of the dental surgeons of the Province of Quebec;

That through his studies and experience he will then possess all the necessary knowledge and qualifications
