CHAP. 3

An Act to authorize the modification of the contract between the Government and the Sisters of Charity of Quebec respecting the maintenance of the insane in the Beauport Asylum.

[Assented to 21st December, 1912]

Preamble. **W**HEREAS it is expedient to raise from one hundred and ten dollars a year to one hundred and twenty dollars a year, until the 31st day of December 1922, the sum payable to the Sisters of Charity of Quebec, in consideration of the care to be hereafter given by the said Sisters to the patients who are confided to them by the Government for treatment at the Beauport Asylum, and whereas it is also expedient to relieve the said Sisters from the obligation to pay any balance due on the claims mentioned in clauses 19 and 20 of their contract;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Modification **1.** The contract entered into on the 23rd day of February

1903, between the Government and the Sisters of Charity of Quebec, and ratified by the act 3 Edward VII, chapter 4, may be changed by the Provincial Secretary, duly authorized thereto by the Lieutenant-Governor in Council, and with the consent of the said Sisters, to the extent mentioned in section 2. ^{of certain contract.}

2. Such change shall be evidenced by a notarial contract *en minute* granting the Sisters of Charity of Quebec from the first day of January 1913 to the 31st day of December 1922, in so far as the Beauport Asylum is concerned, an aggregate sum of one hundred and twenty dollars a year for each patient entrusted to the care of the said Sisters in the Beauport asylum, provided that it appears from the new contract modifying the contract of the 23rd of February 1903, that the said contracts shall expire on the 31st day of December 1922 as far as the Beauport asylum is concerned. ^{Notarial deed to be passed.}

A release of the balance due upon the claims mentioned in clauses 19 and 20 of the contract of the 23rd February 1903 may also be granted to the Sisters of Charity of Quebec by contract hereafter entered into and modifying the said contract of February, 23rd, 1903. ^{Release of certain obligation.}

3. This act shall come into force on the day of its sanction. ^{Coming into force.}

CHAP. 4

An Act respecting the Longue Pointe Asylum.

[Assented to 21st December, 1912]

WHEREAS, it is expedient to raise from one hundred and twelve dollars or from one hundred and ten dollars, to one hundred and twenty dollars a year, until the expiration of the contract, the sum payable to the Community of the Sisters of Charity of Providence, in consideration of the care which the Sisters of the said Community will hereafter give to the insane of both sexes to be confided to them by the Government of this Province. ^{Preamble.}

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The contract passed between the Government and the Community of the Sisters of Charity of Providence on the 13th day of March, 1897, and ratified by the act 9 Edward VII, chapter 5, may be changed by the Provincial Secretary duly authorized ^{Modification of certain contract.}
