

CHAP. 10

An Act to amend the law respecting representation in the
Legislative Assembly

[Assented to 21st December 1912]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Paragraph 30 of article 67 of the Revised Statutes, 1909, R. S., 67, am. as replaced by section 9 of the act 2 George V, chapter 9, is amended by replacing the words "St. Denis ward" in the nineteenth and twentieth lines, by the words "St. Denis and Laurier wards."

2. Paragraph 43 of article 67 of the said statutes, as replaced ^{Id.} by section 12 of the act 2 George V, chapter 9, is amended by replacing the words "Laurier and St. Jean Baptiste wards" in the first and second lines by the words: "St. Jean Baptiste ward, the part of St. Denis ward situated to the southeast of Baby street and Laurier ward less the part situated to the northwest of Baby and Isabeau streets."

3. This act shall come into force on the day of its sanction. ^{Coming into force.}

CHAP. 11

An Act to annex certain lots of the township of Simpson
in the county of Arthabaska, to the county of Drummond,
for electoral and municipal purposes.

[Assented to 21st December 1912]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The lots of land known and designated as being the numbers 13 to 24a both inclusive of the eighth range of the township of Simpson in the county of Arthabaska, and 20, 21 and 22 of the ninth range thereof, are detached from the parish of Saint-Clothilde de Horton in the county of Arthabaska, and annexed for municipal and electoral purposes to the municipality of part of the parish of St-Lucien in the county of Drummond. ^{Transfer of certain lands from Arthabaska to Drummond.}

New name of certain parish. **2.** The municipality of part of the parish of St-Lucien, shall in the future be designated by reason of the annexation effected by section 1 of this act, as: "the municipality of the parish of St-Lucien."

Id., 67 and 75 am. **3.** Paragraphs 2 and 18 of article 67, and paragraphs 2 and 19 of article 75 of the Revised Statutes, 1909, are amended accordingly.

Id. 74, am. **4.** Paragraph 2 of article 74 of the Revised Statutes, 1909, is amended by replacing the words: "less the lots from No. 13 to No. 28 inclusively of the eighth and ninth ranges" in the twenty-first, twenty-second, twenty-third and twenty-fourth lines, by the words: "less lots Nos. 24*b*, 25, 26, 27 and 28 of the eighth range, and lots Nos. 13 to 19, and 23 to 28 both inclusive of the ninth range."

Id., 74, am. **5.** Paragraph 21 of article 74 of the said statutes is amended by replacing the words: "lots from No. 13 to No. 28 inclusive of the eighth and ninth ranges" in the first, second, third and fourth lines, by the words: "and lots Nos. 24*b*, 25, 26, 27, and 28, of the eighth range, and lots Nos. 13 to 19 and 23 to 28 both inclusive of the ninth range."

Coming into force. **6.** This act shall come into force on the day of its sanction.

CHAP. 12

An Act respecting the municipal organization of the county of Saguenay, and to amend articles 283, 291, 293, 927 and 1081 of the Municipal Code and article 75 of the Revised Statutes, 1909.

[Assented to 21st December 1912]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S. 75, am. **1.** Paragraph 57 of article 75 of the Revised Statutes, 1909, is amended by replacing the words following the word "less" in the first line, by the words: "the municipality of St-Pierre de la Pointe aux Esquimaux and the island of Anticosti."

M. C., 283, am. **2.** Article 283 of the Municipal Code, as contained in article 6075 of the Revised Statutes, 1888, and as amended by the act 61 Victoria, chapter 50, section 1, is further amended by repla-
