CHAP. 12

An Act respecting the municipal organization of the county of Saguenay, and to amend articles 283, 291, 293, 927 and 1081 of the Municipal Code and article 75 of the Revised Statutes, 1909.

[Assented to 21st December 1912]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S. 75, am. **1.** Paragraph 57 of article 75 of the Revised Statutes, 1909, is amended by replacing the words following the word "less" in the first line, by the words: "the municipality of St-Pierre de la Pointe aux Esquimaux and the island of Anticosti."

M. C., 283, am. **2.** Article 283 of the Municipal Code, as contained in article 6075 of the Revised Statutes, 1888, and as amended by the act 61 Victoria, chapter 50, section 1, is further amended by repla-

cing the words: "municipality of the parish of St-Pierre de la Pointe aux Esquimaux" in the seventh line, by the words: "municipalities of the county of Saguenay east of the river Aux Outardes."

3. Article 291 of the Municipal Code as contained in article Id., 291 am. 6076 of the Revised Statutes, 1888, is amended by adding to paragraph 2 the following words: "and in the municipalities of the county of Saguenay east of the river Aux Outardes, must have been in possession as proprietor, tenant or occupant, of land of any value."

4. Article 293 of the Municipal Code, as contained in article Id., 293, am. 6077 of the Revised Statutes, 1888, is amended by inserting after the first paragraph, the following:

"In the municipalities of the county of Saguenay east of the river Aux Outardes the Provincial Secretary shall fix the day ^{First election} for the first election, within a reasonable time, and shall ap- ^{in certain} point the chairman of the election. The latter shall give the ^{municipa-} notice required by article 294."

"**927.** In municipalities of the county of Saguenay east of Appeals to the river Aux Outardes, appeals elsewhere taken to the coun- Circuit Court. ty council in cases where such appeals lie, shall be taken to the Circuit Court of the district or county, in accordance with the provisions of title third of book third of the Municipal Code.
