

## C H A P. 26

## An Act respecting the Polytechnic School

[Assented to 21st December, 1912]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** Section 17 of the act 57 Victoria, chapter 23, as amended by the acts 3 Edward VII, chapter 17, section 4; 7 Edward VII, chapter 28, section 1; 8 Edward VII, chapter 31, section 1; 9 Edward VII, chap. 35, section 1, and 1 George V (2nd session), chapter 30, section 2, is further amended by replacing the word "twenty-five," in the fourth line by the word "thirty."

## C H A P. 27

## An Act to amend the act to incorporate the Polytechnic School.

[Assented to 21st December, 1912]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** Section 19 of the act 57 Victoria, chapter 23, is replaced by the following :

Diplomas for  
students of  
Polytechnic  
School.

**" 19.** Laval University, shall, in accordance with its charter, deliver to the students of the Polytechnic School, the diploma of Civil Engineer, Mining Engineer, Electrical Engineer, Railway Engineer, Chemical Engineer, Mechanical Engineer, Industrial Engineer, Architectural Engineer, Master in Decorative Art, and other diplomas according to the special course followed by each student.

Contents of  
diplomas.

Each diploma shall mention that the student has passed the examinations during his course with distinction, or great distinction, or the greatest distinction, according to the internal regulations of the School.

Rights of  
diploma  
holders.

Notwithstanding any law to the contrary, such diploma shall confer upon the recipients, both for the past and future, all

the rights and privileges attached to the exercise and the practice of the profession in respect of which it is granted."

2. Section 21 of the said act is amended by adding the following paragraphs:

"5. The diploma of Electrical Engineer is delivered to a student who is capable of applying the principles of electricity to the needs of industry. Diploma of Electrical Engineer;

"6. The diploma of Railway Engineer is delivered to a student who is capable of applying the principles of the building and working of railways, even from the commercial point of view. Railway Engineer;

"7. The diploma of Master in Decorative Arts is delivered to a student capable of applying the principles of the fine arts, architecture, sculpture and painting, to the ornamenting and furnishing of buildings. Master in Decorative Arts;

"8. The diploma of Architect is delivered to a student who is capable of applying the rules of art to the representation of buildings by means of drawings, including both the technical and the artistic work. Architect.

The holder of a diploma of architect shall as the legal consequence thereof be a member of the Province of Quebec Association of Architects, and shall have the right to practice after payment of the required fees and contributions, and proof of at least twelve months study in the office of a member of the Association during the School's four years' course in architecture, and after a final examination in architectural drawing held before a jury composed of two of its professors and two of the members of the Association appointed by the latter to represent it upon the said jury by resolution duly transmitted to the Polytechnic School, and after one month's notice sent by the School to the Association by registered letter informing the Association of the place, day and hour of the examination. The agreement of two of the members of the jury shall be sufficient to pass the student. Rights of holder of architect's diploma.

Such examination shall last at least ten consecutive hours, in a room, under the supervision of the examiners of the School and of the Association. Examination.

The School shall pay each of the examiners of the Association, a fee of ten dollars per day. Payment of examiners.

The diploma shall be signed by the director of the School of Architecture, and the principal and director of the Polytechnic School, and countersigned by the president and secretary of the Province of Quebec Association of Architects, and by the rector and secretary of Laval University. Signing, &c, of diploma.

The granting of such diploma shall be necessary to authorize any student in the School to practice the profession of architect in the Province. Diploma necessary in certain case.

**Proviso:** Nevertheless the pupils of the Polytechnic School who have already received from the School, diplomas of architect, shall form part of the Association without further examination.

**3.** Section 21a of the act 57 Victoria, chapter 23, as enacted by the act 3 Edward VII, chapter 17, section 5, and amended by the acts 7 Edward VII, chapter 28, section 2; 8 Edward VII, chapter 31, section 2, and 9 Edward VII, chapter 35, section 2, is further amended by replacing the word "two" in the third line, by the word "three."

## C H A P. 28

An Act to amend the acts respecting the Board of Roman Catholic School Commissioners of the city of Quebec.

[Assented to 21st December, 1912]

**Preamble.**

**W**HEREAS the Board of Roman Catholic School Commissioners of the city of Quebec has, by its petition, represented:

That the school municipality of Limoilou has been annexed to the Roman Catholic school municipality of the city of Quebec and it is expedient to increase the number of members of the Board of Roman Catholic School Commissioners of the said city;

That it is necessary that the Roman Catholic Board of School Commissioners of the city of Quebec contract new loans for the purpose of building new school houses, or completing the present school houses generally and that it is also expedient to make certain amendments to the above effect;

Whereas it is expedient to grant the prayer of the said petition;

Therefore, His Majesty with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**Additional

board.**

**1.** On or before the first day of July 1913, the city of Quebec shall appoint an additional member on the Board of Roman Catholic School Commissioners of the city of Quebec.
