

**3.** Section 1 of the act 6 Edward VII, chapter 87, as replaced 6 Ed. VII, c. by the act 8 Edward VII, chapter 32 section 1, is again replaced 87, s. 1 replaced. by the following:

“ **1.** The Roman Catholic Board of School Commissioners of Issue of the city of Quebec, notwithstanding the provisions to the con-bonds, &c. trary contained in section 35 of the act 32 Victoria, chapter 16, may, for the purpose of building, enlarging and improving school houses in the city of Quebec, issue, from time to time, according to the needs of the board, bonds, to an amount not exceeding one million dollars, redeemable by annuities or semi-annuities or in any other manner which the board may adopt, in fifty years at the latest.

Nevertheless the said commissioners may in any other way Temporary temporarily borrow any part of the amount herein authorized, loans, &c. provided the amount do not exceed one hundred thousand dollars.”

**4.** Notwithstanding the provisions of section 36 of the Salary of act 32 Victoria, chapter 16, the Board of Roman Catholic sec.-treas. School Commissioners of the city of Quebec may fix the secretary-treasurer's yearly salary at such amount as it may deem advisable.

**5.** The commissioners, on resolution approved by the Su-Redemption perintendent of Public Instruction, may at any time, if they and re-issue think advisable, and with the consent of the bondholders, of bonds. redeem bonds forming part of their corporate debt, and issue bonds in the place and stead thereof.

**6.** This act shall come into force on the day of its sanction. Coming into force.

## C H A P. 29

An Act respecting the Protestant Board of School Commissioners of the city of Montreal.

[Assented to 21st December, 1912]

**W**HEREAS the Protestant Board of School Commissioners Preamble. of the City of Montreal have, by their petition, represented that it is expedient that legislation should be enacted authorizing the said board to issue additional bonds, or debentures, and to regulate the amount and the form thereof, and the manner of such issue ; and bringing within the jurisdiction of the said board certain territory heretofore not subject thereto.

Whereas it is expedient to grant the prayer of the said petition.

Therefore, His Majesty, by and with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Issue of

authorized.

**1.** The Protestant Board of School Commissioners of the city of Montreal, are hereby authorized and empowered to issue additional bonds, or debentures, to an amount not exceeding five hundred thousand dollars, the said bonds, or debentures, to be payable as to principal in thirty years of date of issue, bearing interest at a rate not exceeding four and one half per cent per annum, with such sinking fund as is necessary to redeem the said bonds at maturity, the bonds to be dated January 1st, 1913. The said school commissioners are authorized to set aside such sum as may be necessary to pay the said interest and sinking fund.

**2.** Such additional bonds, or debentures, shall be issued in conformity with the act 54 Victoria chapter 53.

**3.** The said bonds, or debentures, shall be in the following form, which is hereby declared to be legal and valid to all intents and purposes, and to confer upon the purchaser thereof all the rights and privileges heretofore recognized by law:

PROTESTANT BOARD OF SCHOOL COMMISSIONERS OF THE CITY OF

Payment of principal and interest provided for and payable by the city of Montreal under the acts of the Legislature of the Province of Quebec.

The Protestant Board of School Commissioners of the city of Montreal promise to pay to the bearer hereof, at the office of the city treasurer in the city of Montreal on the first day of January, one thousand nine hundred and forty-three (1943) on presentation and surrender of this bond, the sum of one thousand dollars (\$1,000.00) in gold coin of its present weight and fineness, for value received.

The Protestant Board of School Commissioners of the city of Montreal will also pay on the first days of January and July in each and every year, until the final redemption of this bond, interest at the rate of four and one half per centum ( $4\frac{1}{2}\%$ ) per annum, on presentation at the same place of the proper coupons, as hereto annexed:

The city of Montreal is bound by law to retain in its hands,

out of the yearly proceeds of the school tax in the city, a sufficient sum to pay the interest and form a sinking fund for the repayment of these bonds at maturity, and the bearer of this bond shall have the right to claim from the city of Montreal payment of capital and interest when due.

This bond is one of five hundred (500) of a like tenor, date and effect, and issued under the authority of the acts of the Legislature of the Province of Quebec, and of a resolution of the Protestant Board of School Commissioners of the city of Montreal, passed at a meeting of the said board, duly called and held on the tenth day of October, one thousand nine hundred and twelve (1912).

From and after the first day of July, one thousand nine hundred and thirteen all that part of the territory <sup>Annexation authorized, &c.</sup> comprised in St. Denis ward of the city of Montreal, and not mentioned in the act 1 George V, (second session,) chapter 28, section 1, shall, as regards all Protestants residing, or having property therein, be added to and form part of the school municipality under the jurisdiction and control of the Protestant Board of School Commissioners of the city of Montreal, and the school trustees for the school municipality of Amherst Park, shall cease thenceforth to have any control, or jurisdiction over the said territory, and all rights,

property, debts and obligations of the said school trustees shall vest in and be assumed by the Protestant Board of School Commissioners of the city of Montreal provided however, that nothing in this act shall deprive any person who at the time of such annexation was a creditor of the said school corporation of any right, remedy, privilege, or recourse, which he would have had, or could have exercised, if this act had not come into force.

**5.** The territory heretofore known and designated as Bordeaux ward of the city of Montreal, together with any territory which may for municipal purposes be annexed thereto prior to the 1st day of July, 1913 shall, from and after the date aforesaid, and for Protestant school purposes only, form part of the territory of and be subject to the jurisdiction and control of the Protestant Board of School Commissioners of the city of Montreal.

**6.** From and after the 1st day of July, 1913, the dissentient school trustees of Sault-au-Récollet and of St. Laurent shall cease to have jurisdiction over the territory described in the foregoing section provided that all their corporate rights and obligations as regards the territory aforesaid shall thenceforth be and become vested in the Protestant Board of School Commissioners of the city of Montreal, and the said transfer and annexation of the said territory shall in no manner affect or extinguish any right or action in favour of or against the said trustees, which rights or actions, to the extent above indicated shall thenceforth exist or lie in favour of or against the said Protestant Board of School Commissioners of the city of Montreal.

## C H A P . 30

An Act respecting The Catholic School Commission of the city of Montreal.

[Assented to 21st December, 1912]

Preamble.

**W**HEREAS the Catholic School Commission of the city of Montreal has, by its petition, represented that it is necessary for it to acquire and build new schools within the territory administered by it, and improve schools already built:

Whereas it prays for authority to contract a new loan of five hundred thousand dollars for such purposes;
