

property, debts and obligations of the said school trustees shall vest in and be assumed by the Protestant Board of School Commissioners of the city of Montreal provided however, that nothing in this act shall deprive any person who at the time of such annexation was a creditor of the said school corporation of any right, remedy, privilege, or recourse, which he would have had, or could have exercised, if this act had not come into force.

5. The territory heretofore known and designated as Bordeaux ward of the city of Montreal, together with any territory which may for municipal purposes be annexed thereto prior to the 1st day of July, 1913 shall, from and after the date aforesaid, and for Protestant school purposes only, form part of the territory of and be subject to the jurisdiction and control of the Protestant Board of School Commissioners of the city of Montreal.

6. From and after the 1st day of July, 1913, the dissentient school trustees of Sault-au-Récollet and of St. Laurent shall cease to have jurisdiction over the territory described in the foregoing section provided that all their corporate rights and obligations as regards the territory aforesaid shall thenceforth be and become vested in the Protestant Board of School Commissioners of the city of Montreal, and the said transfer and annexation of the said territory shall in no manner affect or extinguish any right or action in favour of or against the said trustees, which rights or actions, to the extent above indicated shall thenceforth exist or lie in favour of or against the said Protestant Board of School Commissioners of the city of Montreal.

CHAP. 30

An Act respecting The Catholic School Commission of the city of Montreal.

[Assented to 21st December, 1912]

Preamble.

WHEREAS the Catholic School Commission of the city of Montreal has, by its petition, represented that it is necessary for it to acquire and build new schools within the territory administered by it, and improve schools already built:

Whereas it prays for authority to contract a new loan of five hundred thousand dollars for such purposes;

Whereas it moreover prays, by its said petition, for authority to found, outside the limits of its own territory, institutions known as "summer school colonies" for the pupils frequenting its city schools and also for special powers to more easily expropriate lands and buildings for school purposes;

Whereas it is expedient to grant the prayer to such effect contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 1 of the act 54 Victoria chapter 53, as amended 54 V., c. 53, by the acts 63 Victoria, chapter 99, section 1; 5 Edward VII, ^{s. 1, am.} chapter 90, section 1; 6 Edward VII, chapter 84, section 1; 9 Edward VII, chapter 39, section 1; 1 George V (first session) chapter 22, section 1, and 2 George V chapter 27, section 1, is further amended by adding the following subsections:

m. The Catholic School Commission of the city of Montreal ^{Issue of} is, nevertheless, authorized to issue bonds and debentures ^{bonds, &c.} for a further amount of five hundred thousand dollars, over and above the loans already contracted.

n. Such bonds and debentures shall be issued in accordance ^{Law appli-} with the acts 54 Victoria, chapter 53, and 1 George V (second ^{cable.} session) chapter 60, section 30.

2. The said school commission may found, in localities ^{Summer} which it may deem suitable and outside of its own territory, ^{school colo-} institutions known as "summer school colonies" for the use of children frequenting its city schools, and may rent and purchase any land suitable for such purpose, and may aid by subsidies the establishment of such institutions, or make arrangements with the proprietor of any such institution for the admission of its pupils thereto, fix the conditions of admission, and permit free entrance to poor pupils, may ask and receive contributions of any kind for the purposes mentioned, and make necessary rules and regulations for the effective management of such institutions.

3. This act shall come into force on the day of its sanction. ^{Coming into}
