An act to amend the acts respecting the School Commissioners
for the city of Westmount.

[Assented to 21st December, 1912]

WHEREAS, the School Commissioners for the city of Preamble.
Westmount have, by their petition, represented that
it has become necessary to provide additional school accom-
modation in the city and have prayed for the passing of an
act increasing their borrowing powers,

And whereas it is expedient to grant the prayer of the
said petition;

Therefore, His Majesty, with the advice and consent of
the Legislative Council and of the Legislative Assembly of
Quebec, enacts as follows:

1. Section 8 of the act 56 Victoria, chapter 80 as replaced 56 V., c. 80,
by section 1 of the act 62 Victoria, chapter 72 and again re- s. 8 replaced.
placed by section 1 of the act 8 Edward VII, chapter 35,
is again replaced by the following:

“ **8.** The said School Commissioners, with the authoriz- Expenditure
ation of the Superintendent of Public Instruction, may expend, for lands, &c.
from time to time, such sums of money as they may deem
necessary for the acquisition of lands and the constructing
and furnishing of school-houses or for any purposes within
their jurisdiction, without limitation as to the amount to be
expended on any one school-house, provided that the whole Proviso.
debt of the said school corporation shall not, at any time,
exceed the sum of one million dollars. ”

C H A P. 33

An Act to amend articles 3076 and 3077 of the Revised Sta-
tutes 1909.

[Assented to 21st December, 1912]

HIS MAJESTY, with the advice and consent of the Legis-
lative Council and of the Legislative Assembly of Que-
bec, enacts as follows:

1. Article 3076 of the Revised Statutes, 1909, as conditionally R. S. 3076,
amended by section 2 of the act 1 George V (1st session), chap-am.

ter 8, and by paragraph F of section 14 thereof, and as amended by paragraph E of section 9 of the act 1 George V (1st session), chapter 9, is further amended:

a. By replacing the words : " Seventeen judges of the Superior Court shall reside in the city of Montreal one of whom shall have special charge of the district of Terrebonne " in the first, second and third lines by the words : " Eighteen judges of the Superior Court shall reside in the city of Montreal, one of whom shall have special charge of the district of Terrebonne, and another of the district of Beauharnois. "

b. By striking out the word " Beauharnois " in the eighteenth line.

Id., 3077, am. **2.** Article 3077 of the Revised Statutes, 1909, is amended by replacing paragraph 1 by the following:

" **3077.** 1. The judge to whom the district of Terrebonne is assigned and the judge to whom the district of Beauharnois is assigned, shall each perform his ordinary functions in any court wherein the judges of the court have jurisdiction, whenever his services are not required in his district."

An Act to amend article 3449 of the Revised Statutes, 1909,
respecting the summoning of jurors.

1. Article 3449 of the Revised Statutes, 1909, is amended by inserting after the word "travellers", in the first line of the third paragraph, the words: "or as lumbermen, contractors or foremen in the woods".
