25. Should the said Commission be dissolved, all property owned or held by it under this act shall revert to the city of Maisonneuve or its representatives who shall be subrogated in all its ights and obligations.

CHAP. 60

An Act to amend the charter of the town of Magog.

[Assented to 21st December, 1912]

Preamble.

WHEREAS the corporation of the town of Magog has by petition represented that it is desirable and in the public interest that certain additional powers be conferred upon it, and certain amendments be made to its charter, the acts 53 Victoria, chapter 79; 60 Victoria, chapter 68; 1 George V, (1st session) chapter 60, and 2 George V, chapter 66, and whereas it is expedient to grant the prayer contained in the said petition.

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:—

1. Article 4 of the act 53 Victoria, chapter 79, as replaced by article 2 of the act 60 Victoria, chapter 68, is again replaced by the following:

Wards.

“ 4. The council of the town of Magog may divide the town into six wards.”

replaced.

2. Article 5 of the act 53 Victoria, chapter 79, as replaced by article 3 of the act 60 Victoria, chapter 68, is again replaced, by the following.:

Certain
councillors,

“ 5. The councillors and officers of the town in office at the passing of this act, shall remain in office until the expiration of

their term of office, or until the first general election which will be held after the coming into force of this act.

The said general election shall take place on the first of February, 1914".

First general election.

3. The following articles of the Revised Statutes, 1909, shall apply to the town of Magog, and shall be considered as forming part of its charter, namely:

4. Article 7 of the act 53 Victoria, chapter 79, is replaced by the following:

"**7.** The municipal council of the town shall consist of one mayor and six councillors who shall be elected for a period of two years, or until the election of their successors, in the manner and for the time provided by the Revised Statutes 1909, articles 5413 to 5552 inclusive, and their amendments."

Municipal council.

5. Article 18 of the act 53 Victoria, chapter 79, is replaced by the following:

Id., s. 18 replaced.

"**18.** The council of the town shall replace any councillor whose seat becomes vacant, owing to death, removal or any other cause."

Filling vacancies.

Such councillor shall be appointed immediately after the vacancy occurs, and shall remain in office for the remainder of the term for which his predecessor was elected."

6. Article 5321 of the Revised Statutes, 1909, is replaced for the town of Magog, by the following:

R. S. 5321 replaced for town.

"**5321.** The council may appoint permanent or special committees, composed of as many of its members as it may deem necessary to supervise the administration of the several civic departments for which they are respectively named, and to manage such business as it may, by by-law or resolution, assign to them."

Permanent &c., committees.

The permanent committees shall be formed at the first meeting after the annual general election, and special committees at any time whenever necessary or expedient."

When appointed.

Replacing of members. The council may replace any member of the said committees whenever it thinks proper.

Mayor a member. The mayor shall be a member *ex-officio* of all committees, and shall have a right to vote therein.

Rendering of accounts. The committees shall render account of their labors and their decisions by report signed by their chairman or by a majority of the members who compose them.

Ratification of committee reports. No report of a committee shall have any effect until it has been ratified or adopted by the council."

Id., 5358 replaced for town. **7.** Article 5358 of the Revised Statutes, 1909, is replaced, for the town of Magog, by the following:

Auditors. " **5358.** The council shall, at its first session in the month of March of each year or as soon thereafter as possible, appoint one or two auditors who shall perform the duties of their office until the entry into office of their successors."

Id., 5360 replaced for town. **8.** Article 5360 of the Revised Statutes, 1909, is replaced, for the town of Magog, by the following:

Appointment of assessors. " **5360.** The council shall at its first regular sitting in the month of March appoint every year as many assessors as it may deem necessary.

Tenure of office. Such assessors shall hold office until their successors are appointed.

Remuneration. The remuneration of such assessors shall be fixed, from time to time, by the council, which shall appoint one of the assessors chairman of the board.

Division of labour. The council shall determine the manner in which the assessors shall divide their labors."

Id., 5801 replaced for town. **9.** Article 5801, of the Revised Statutes, 1909, is replaced, for the town of Magog, by the following:

Recovery of penalties. " **5801.** Penalties imposed by the by-laws of the council, or by the provisions of this chapter or of the charter, shall be recoverable either before the district magistrate the recorder of the town if there be one or any justice of the peace, or by an action for debt before the District Magistrate's Court or the Circuit Court of the county of Stanstead, sitting at Magog."

Id., 5789 replaced for town. **10.** Article 5789, of the Revised Statutes, 1909, is replaced, for the town of Magog, by the following:

Temporary loans. " **5789.** Notwithstanding the provisions of this subsection the council may, pending the collection of the general and special taxes and of the water-rate, on mere resolution and without being bound to obtain the approval of the electors who are proprietors or of the Lieutenant-Governor in Council, contract temporary loans, from time to time, by means of notes,

for a period not exceeding the then current fiscal year, and on such terms and conditions as the council may deem expedient, to an amount not exceeding at any time one-fourth of the revenue of the municipality then due and exigible.

The amount so borrowed, however, shall never exceed ^{Limit thereof.} twenty-five thousand dollars.

The council may further, by a resolution to that effect and ^{Special loan.} without other formality, borrow an amount not exceeding sixty thousand dollars either on notes or by a hypothec on its electric works; provided, however, that the amount so borrowed be used to pay the balance of the amount due the Dominion Textile Company, Limited, to complete the said electric works or of improvements to the same."

CHAP. 61

An Act to amend the charter of the town of Verdun.

[Assented to 21st December, 1912].

WHEREAS the corporation of the town of Verdun, has, ^{Preamble.} by petition, represented that it is desirable that an act be passed to amend its charter, the act, 7 Edward VII, chapter 73, and to be given certain powers not granted by the said act and further to exclude certain of the provisions thereof;
