

for a period not exceeding the then current fiscal year, and on such terms and conditions as the council may deem expedient, to an amount not exceeding at any time one-fourth of the revenue of the municipality then due and exigible.

The amount so borrowed, however, shall never exceed ^{Limit thereof.} twenty-five thousand dollars.

The council may further, by a resolution to that effect and ^{Special loan.} without other formality, borrow an amount not exceeding sixty thousand dollars either on notes or by a hypothec on its electric works; provided, however, that the amount so borrowed be used to pay the balance of the amount due the Dominion Textile Company, Limited, to complete the said electric works or of improvements to the same."

CHAP. 61

An Act to amend the charter of the town of Verdun.

[Assented to 21st December, 1912].

WHEREAS the corporation of the town of Verdun, has, ^{Preamble.} by petition, represented that it is desirable that an act be passed to amend its charter, the act, 7 Edward VII, chapter 73, and to be given certain powers not granted by the said act and further to exclude certain of the provisions thereof;

And whereas it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 1 of the act 7 Edward VII, chapter 73, is replaced by the following:

“**1.** The territory comprised within the limits herein-after described, is erected into a city municipality under the name of the “City of Verdun”, and the inhabitants of the said municipality are constituted a city corporation under the name of “City of Verdun.”

2. Article 5776 of the Revised Statutes 1909, is replaced, for the city, by the following:

“**5776.** For the purpose of carrying out the permanent works in the list hereto attached as schedule A, the council is authorized to borrow on the credit of the city during the three years following the coming into force of this act, a sum of money not exceeding two hundred and fifty thousand dollars per annum, which sum shall be exclusively employed to carry out the permanent works mentioned in the said list. The sums so borrowed shall be spent in the various wards of the city in proportion to the development thereof, or as the proprietors interested shall require the same. Notwithstanding any law to the contrary the council is authorized, for the purpose aforesaid to effect such loans, by issuing bonds or debentures of the city, by by-law or resolution, and such various issues of bonds or debentures shall be exempt from the formalities prescribed in such cases by the Revised Statutes or by the charter,”

An Act to amend the charter of the town of St. Lambert.

[Assented to 21st December, 1912]

Preamble.

WHEREAS the corporation of the town of St. Lambert has, by its petition, represented, that it is right and desirable that additional powers be granted it and that certain amendments be made to its charter, the act 61 Victoria, chapter 60 and its amendments;

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

incorporated.
Name.

1. The inhabitants and rate-payers of the town of St. Lambert and their successors, are and shall remain a corporation under the name of the "Town of St. Lambert".

2. The town is subject to the operation of chapter first, of title eleventh of the Revised Statutes, 1909, (articles 5256 to 5884) and its amendments, except in so far as the same may be inconsistent with the provisions of this act.
