8. The association shall be administered and governed by: Government of association.

a. An executive committee under the control of the board of directors;

b. A board of directors subject to the decisions of the general meeting of the members which meeting shall decide finally on all matters within the scope of the association.

9. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 96

An Act to incorporate the Hebrew Free Loan Association.

[Assented to 21st December, 1912]

WHEREAS Zigmund Fineberg, Jacob A. Jacobs, Tobias Glickman, Moses Albert, Hiram Levy, Archibald H. Jackson, Nathan H. Godinsky, Abraham Levin, Philip Popliger, Solomon Kellert, Eli W. Jacobs, Abraham Harris, Moses Slabosky, Manuel Levitt and Abraham Schachter have by their petition represented: Preamble.

That they have founded an association known as the "Hebrew Free Loan Association," the object of which is to loan money, free of interest or charge, to any person, irrespective of creed or nationality, in need of temporary aid;

Whereas they have by their petition prayed to be constituted a corporation, and it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The said Zigmund Fineberg, Jacob A. Jacobs, Tobias Glickman, Moses Albert, Hiram Levy, Archibald H. Jackson, Nathan H. Godinsky, Abraham Levin, Philip Popliger, Solomon Kellert, Eli W. Jacobs, Abraham Harris, Moses Slabosky, Manuel Levitt and Abraham Schachter, and those who may hereafter become members of the said Association are hereby constituted a body politic and corporate under the name of "The Hebrew Free Loan Association". Persons incorporated.

Name.

- Corporate seat.** **2.** The corporate seat shall be in the city of Montreal and the corporation may:
- Objects of corporation.** 1. Lend money free of interest discount or charge whatsoever to poor and indigent persons, relieve people in temporary distress, and render them such aid as to prevent them from sinking into pauperism;
2. Make, amend and repeal regulations and by-laws not contrary to law which it may deem essential and necessary for its interests and government;
- Perpetual succession.** **3.** The corporation hereby constituted shall have perpetual succession.
- Powers.** It may have a common seal which it may alter at will, sue and be sued, borrow, sign bills of exchange and promissory notes, hold, accept and acquire by any legal title moveable or immoveable property, which it may sell, convey, lease transfer or exchange, or otherwise dispose of by any title whatsoever, provided always that the value of the immoveable property held shall not exceed two hundred thousand dollars, according to the municipal valuation. The said corporation may also hypothecate its immoveables.
- Statement to L. G. in C.** **4.** The corporation shall, when required so to do by the Provincial Secretary, transmit to the Lieutenant-Governor in Council, a detailed statement of its property, the names of its officers and agents, and a certified copy of its rules and regulations.
- Coming into force.** **5.** This act shall come into force on the day of its sanction.

C H A P. 97

An Act to amend the act 55-56 Victoria, chapter 64, to incorporate *Les administrateurs de l'Université Laval à Montréal*.

[Assented to 21st December, 1912]

- Preamble.** **W**HEREAS *Les administrateurs de l'Université Laval à Montréal* have by their petition represented that it is expedient to amend their charter so as to authorize them to borrow money for the erection of school buildings and for other purposes;
- Whereas it is expedient to grant their prayer;
- Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
