CHAP. 116

An Act to authorize *La Compagnie Hydraulique Stadacona* to exercise certain powers of expropriation for the erection of its poles and the installation of its transmission lines, in accordance with the Quebec Railway Act.

[Assented to 21st December, 1912]

Preamble.

WHEREAS *La Compagnie Hydraulique Stadacona* of Quebec, has by its petition represented :

That it was incorporated on the 13th March 1911 by letters patent under the great seal of the Province of Quebec in virtue of the Quebec Companies' Act;

That it has acquired all the assets of the Quebec Electric Power Company and has spent considerable amounts on the St. Anne river at the place called the Seven Falls, for dams and works for producing electricity and it will be obliged to establish lines for the transmission of the electric power so produced in and through the territory where it is authorized to carry on its operations and business;

That, beyond a doubt, it will not always be able to come to an agreement with proprietors, for the acquisition by mutual agreement of the right of way it may need for the erection of its poles and the installation of its transmission lines and, in order that it be not delayed in its operations, it is indispensably necessary that it should be able to have recourse to expropriation under practically the same conditions as railway companies ;

Whereas the company has prayed that such powers be granted it and it is expedient to grant its prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enact as follows :

1. Without prejudice to the powers it already possesses ^{Company} under its letters patent of incorporation, *La Compagnie Hy-* ^{authorized to} *draulique Stadacona* may ^{acquire, &c.} acquire and take possession of the ^{certain lands} lands and right of way required for the erection of its poles ^{&c.} and the installation and maintenance of its transmission lines for electric power, by proceeding in the manner prescribed by articles 6592, 6593 and 6594 of the Revised Statutes, 1909, *mutatis mutandis*.
