

C H A P . 131

An Act to authorize the Bar of the Province of Quebec to admit Léon Virolet among its members after examination.

[Assented to 21st December, 1912]

WHEREAS Léon Virolet, of the city of Paris, France, Preamble.
has by his petition represented that he is a Bachelor of Letters of the University of Paris, a Licentiate in Law of the faculty of Paris; that he has taken the oath as advocate before the *Cour d'Appel* of Paris; that he has an advocate's office at No. 21 *rue Le Peltier* in Paris and at No. 34 King's street, Cheapside, in London and wishes to be admitted as member of the Bar of the Province of Quebec, after examination;

Whereas the General Council of the Bar of the Province of Quebec has approved the petitioner's request and consented that his petition be granted;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

C H A P . 132

An Act to authorize the College of Dental Surgeons of the Province of Quebec, to admit Leo Doran among its members.

[Assented to 21st December, 1912]

WHEREAS Leo Doran, of Montreal, a holder of a diploma Preamble.
from Toronto University as Doctor of Dental Surgery, has
by his petition represented:

That he has obtained a diploma of Doctor of Dental Surgery from Toronto University and a license from the Royal College of Dental Surgeons of the Province of Ontario;

That he has since then passed the examinations required by the College of Dental Surgeons of the Province of Quebec, for admission to the study of dental surgery in this Province, in order to permit him to obtain a license to practise dental surgery in this Province;

That he is qualified to practise dental surgery, but cannot obtain his license without having completed the period of study required by law from the date of his admission to study dental surgery;

That he wishes to be admitted among the members of the College of Dental Surgeons of the Province of Quebec, after passing the examinations for admission to practise;

That he has obtained the consent of the College of Dental Surgeons of the Province of Quebec to the passing of an act authorizing the said College to grant him the necessary license for the practice of his profession, after primary and final examinations;

And whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Leo Doran among its members and to grant him the necessary license to practise dental surgery in this Province after primary and final examinations.

CHAP. 133

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Marie André de Souffron, of Montreal, dental surgeon, among its members.

[Assented to 21st December, 1912]

Preamble.

WHEREAS Marie André de Souffron, of Montreal, dental surgeon of the Faculty of Medicine, Paris, has by his petition represented:

That he has obtained the degree of Doctor of Dental Surgery from Laval University in Montreal;

That he has also obtained a diploma of dental surgeon from the Faculty of Medicine of Paris, France, after complying with all the formalities of the French law in such cases;

That he is qualified to practise dental surgery, but that he cannot do so without obtaining a license from the College of Dental Surgeons of the Province of Quebec and being admitted among the members of such College;
