

That he is qualified to practise dental surgery, but cannot obtain his license without having completed the period of study required by law from the date of his admission to study dental surgery;

That he wishes to be admitted among the members of the College of Dental Surgeons of the Province of Quebec, after passing the examinations for admission to practise;

That he has obtained the consent of the College of Dental Surgeons of the Province of Quebec to the passing of an act authorizing the said College to grant him the necessary license for the practice of his profession, after primary and final examinations;

And whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Leo Doran among its members and to grant him the necessary license to practise dental surgery in this Province after primary and final examinations.

CHAP. 133

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Marie André de Souffron, of Montreal, dental surgeon, among its members.

[Assented to 21st December, 1912]

Preamble.

WHEREAS Marie André de Souffron, of Montreal, dental surgeon of the Faculty of Medicine, Paris, has by his petition represented:

That he has obtained the degree of Doctor of Dental Surgery from Laval University in Montreal;

That he has also obtained a diploma of dental surgeon from the Faculty of Medicine of Paris, France, after complying with all the formalities of the French law in such cases;

That he is qualified to practise dental surgery, but that he cannot do so without obtaining a license from the College of Dental Surgeons of the Province of Quebec and being admitted among the members of such College;

That he has obtained the consent of the College of Dental Surgeons of the Province of Quebec, to the passing of an act to authorize the said college to grant him the necessary license to practise his profession after primary and final examinations for admission to study and to practice;

And whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

CHAP. 134

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Allan McDonald Strang among its members.

[Assented to 21st December, 1912]

WHEREAS Allan McDonald Strang of Montreal, Doctor of Preamble.
Dental Science, has by his petition represented:

That he has obtained a diploma of Doctor of Dental Science from the school of Dental Surgery of McGill University, in Montreal, after having duly followed the regular course of lectures of the said school during the term required by law;

That he began to follow the lectures of the said school before having obtained his certificate of admission to the study of dental surgery;

That he has since passed the examinations required by the College of Dental Surgeons of the Province of Quebec, for admission to the study of dental surgery in this Province;

That he is qualified to practise Dental Surgery but that he cannot obtain his license until he has completed the term required by the general law from the date of his certificate of admission to the study of dental surgery;
