

## CHAP. 6

An Act to amend the act 1 George V (1st session), chapter 9, respecting the court-house and gaol at Roberval.

[Assented to 3rd April, 1912.]

Preamble.

**W**HEREAS by the act 1 George V (1st session), chapter 9, the county of Lake St. John was made a district for the purposes of the administration of justice under the name of the "district of Roberval," with its chief place in the town of Roberval, the same to take effect from the date mentioned in a proclamation to be issued after compliance with the formalities mentioned in section 6 of the said act;

Whereas by the same act the corporation of the town of Roberval, and the corporations of certain other municipalities, were authorized to build a court-house and gaol, for the needs of the new district;

Whereas the said court-house and gaol were built according to plans and specifications approved by the Lieutenant-Governor in Council;

Whereas by section 5 of the said act, the corporation of the town of Roberval is authorized to transfer, by contract, to the Government of this Province, the property in the said court-house and gaol upon the conditions to be arranged between the Government and the said corporations;

Whereas the said court-house and gaol have cost fifty-seven thousand dollars, of which forty-four thousand dollars have been paid by the said town of Roberval and thirteen thousand by the other municipalities in the county;

Whereas it is now expedient that the Government should become proprietor of the said immoveables in order that, after compliance with the other conditions, the proclamation mentioned in section 6 of the said act may be issued;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** It shall be lawful for the Lieutenant-Governor in Council to acquire the property in the court-house and gaol of the district of Roberval upon the conditions hereinafter mentioned, and the corporation of the town of Roberval is authorized, upon resolution duly passed for the purpose, to transfer the property in the said immoveables.

**2.** It shall be lawful for the Lieutenant-Governor in Council to pay twenty-seven thousand one hundred and twenty-five dollars to the corporation of the town of Roberval, and seven

thousand eight hundred and seventy-five dollars to the corporation of the county of Lake St. John No. 2, for the other municipalities interested, in order to acquire the ownership in the said immoveables.

**3.** The said sale shall be made on the following conditions: <sup>Conditions of sale.</sup>

*a.* The corporation of the town of Roberval shall have the right to occupy, free of charge, the present council chamber and the present secretary-treasurer's office in the said court-house and goal;

*b.* The county council of the second division of the county of Lake St. John shall have the right to occupy the present registry office free of charge, and shall have the right to sit in the council chamber;

*c.* The aforesaid rights of occupation may be exercised for ten years;

*d.* At the expiration of the said ten years, the Government shall have the right, on payment of the sum of sixteen thousand eight hundred and seventy-five dollars, to the corporation of the town of Roberval and five thousand one hundred and twenty-five dollars to the second division of the county of Lake St. John, to put an end to the aforesaid rights of occupation, and the council of the corporation of the town of Roberval, and that of the second division of the county of Lake St. John, shall no longer have the right to occupy any part of the said building for any purpose.

**4.** The Minister of Public Works and Labour is charged with carrying out this act, and with signing, for and in the name of the Government, after approval by the Lieutenant-Governor-in Council, all deeds necessary to effect such sale. <sup>Who to carry out act, &c.</sup>

**5.** The payments to be made in virtue of this act, shall be made out of the building and jury fund. The Provincial Treasurer may allow out of any unappropriated moneys the amounts necessary to make the said payments. <sup>Payments whence made.</sup>

**6.** To repay the Treasury the sums paid in virtue of this act, and the interest accrued thereon, at the rate of four per cent. per annum, a special fund shall be established consisting of the moneys arising from the dues imposed in the district of Roberval under article 3550 of the Revised Statutes, 1909. <sup>Special fund.</sup>

**7.** This act shall come into force on the day of its sanction. <sup>Coming into force.</sup>
