CHAP. 72

An Act to incorporate the town of East Angus.

[Assented to 14th March, 1912.]

WHEREAS Stanley A. Banfill, physician, Lockhart R. Willard, hotel keeper, James A. Planche, trader, Louis Nolet, mechanic, Louis Reid, mechanic, Joseph A. Fréchette, trader, Samuel Church, farmer, Herbert H. Cooper, merchant, Horace Sawyer, gentleman, Robert H. Edwards, farmer, and others, being a majority of the ratepayers of that portion of the township of Westbury comprised within the limits of the town of East Angus, as described in section 1 of this act, have by petition prayed that the said territory be detached from the municipality of the township of Westbury, and be erected into a town municipality, governed by the Cities' and Towns' Act, under the name of "The Town of East Angus";

Whereas for the better administration of the said territory and the greater advantage of its inhabitants, it is expedient to grant the prayer contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The town of East Angus shall comprise the following Boundaries
territory, to wit: Lots 11, 12, 13, 14, and part of 15, in the of town.
second range of the primitive survey of the township of Westbury, now known as lots 11a to 11g inclusive, lots 12-1 to 12-92 inclusive, lots 13-1 to 13-54 inclusive, lots 14-1 to 14-56 inclusive, and lots 15a to 15f in range two (2) of the official cadastral plan and book of reference of said township of Westbury, and lots 11, 12, 13, 14, and part of 15, in the third (3rd) range of the primitive survey of the said township of Westbury, now known as lots 11a to 11k inclusive, 12a to 12e inclusive, lots 13-1 to 13-42 inclusive, lots 14-1 to 14-37 inclusive, lots 15a, 15b, and that portion of the lot 15c lying northerly of the centre of the St. Francis river in the third range on the official cadastral plan and book of reference for said township of Westbury; and bounded as follows:—On the north

by the range line between ranges three and four; on the east by the line between the primitive lots 15 and 16, running south until said line strikes the St. Francis river, thence to the centre of the St. Francis river, and thence following the centre of the St. Francis river to a point opposite 15f in range two, thence in a straight line until the same strikes the division line between lots 15 and 16 of the primitive survey, thence following the line between lots 15 and 16 until it strikes the range line between ranges one and two; on the south by the line between ranges one and two, and on the west by the division line between lots ten and eleven of the primitive survey.

Persons incorporated. **2.** The inhabitants and rate payers in such territory shall constitute a town corporation under the name of "The Town of East Angus" for municipal, and, from 1st July, 1912, school purposes.

Law to apply. **3.** The said town shall be subject to the "Cities' and Towns' Act" except in so far as the same may be departed from by, or be inconsistent with, the provisions of this act.

By-laws, &c., not affected. **4.** All proces-verbaux, assessment rolls, by-laws, orders, lists, rolls, plans, resolutions, ordinances and enactments now in force in the territory described in section 1 of this act shall continue to have full force and effect until set aside, amended, repealed or fulfilled, or unless they be inconsistent with this act.

Wards. **5.** The town shall be divided into three wards.

North. The North ward shall comprise the railway of the Quebec Central Railway Company, and all the territory lying northerly thereof;

Centre. The Centre ward shall comprise all the territory between the railway of the Quebec Central Railway Company and a line running through the centre of the St. Francis river;

South. The South ward shall comprise all the territory south and westerly of the centre of the St. Francis river.

Numbering of seats of aldermen. The seats of the aldermen elected for each of the wards shall bear the numbers one and two for the North ward, three and four for the Centre ward, and five and six for the South ward.

Number of aldermen. **6.** The number of aldermen shall be six, two for each ward.

First general election. **7.** The first general election shall be held in May 1912. Nomination of candidates shall take place on the 1st day of May, and voting, if there be any contest, one week later.

The secretary-treasurer shall be the returning officer for such first election.
