CHAP. 78

An Act to incorporate the municipality of Ivry-on-the-Lake.

[Assented to 3rd April, 1912.]

WHEREAS, Edward Black Greenshields, merchant, Edward Field Hebden, banker, Robert Starke, merchant, James Oliver, merchant, and John Pitblado, broker, of the municipality of the parish of St. Agathe des Monts, proprietors, residents and rate-payers of the said municipality, have, by their petition, represented that it is in the public interest that the parts of the municipalities of the parishes of St. Agathe des Monts and of St. Faustin, hereinafter described, be organized as a distinct municipality; Preamble.

Whereas, it is impossible for the petitioners to proceed under article 37a of the Municipal Code, because they have been unable to obtain the consent of the majority of the electors of the remaining portion of the said municipalities of the parishes of St. Agathe des Monts and of St. Faustin;

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. After the day of the sanction of this act the following pieces of territory shall be detached respectively from the municipalities of the parishes of St. Agathe des Monts and of St. Faustin. ^{Description of territory of municipality.}

(a) A piece of territory bounded on the north by the line between the ranges 6 and 7 of the township of Beresford; on the west by the line dividing the townships of Beresford and Wolfe; on the south by the range line between the ranges 2 and 3 of the township of Beresford; and on the east by the line separating lots 27 and 28 in the ranges 3, 4, 5 and 6 in the township of Beresford.

(b) A piece of territory described as follows: Lots 37a

38a, 39a, 40a, 41a, 42a, 43a, and 44a, in the second range of the township of Beresford.

(c) A piece of territory situated in the municipality of the parish of St. Faustin in the township of Wolfe, bounded on the north by the line between ranges 3 and 4 of the township of Wolfe; on the west by the line between lots 5 and 6 of the third range of the said township; on the south by the line between the ranges 2 and 3 of the said township; and on the east by the line between the townships of Beresford and Wolfe, and shall form a separate municipality under the name of "The Municipality of Ivry-on-the-Lake".

Name of municipality.

Cadastre to which lot numbers refer.

2. All the numbers of the lots mentioned in this description are those of the official plan of the cadastres of the portions constituting municipalities of the parishes of St. Agathe des Monts and St. Faustin.

M.C., to apply.

First and subsequent elections.

3. All the provisions of the Municipal Code shall apply to the said municipalities, but the first election of councillors of the municipality of Ivry-on-the-Lake shall be held in the said municipality, on 25th of May, 1912, and subsequent elections shall be held on the date and in the manner prescribed by the Municipal Code.

Presiding officer at elections, &c.

4. Such elections shall be presided over by a person chosen by the majority of the electors present. The person presiding at such meeting shall be subject to articles 299, 300, 301, 302, 303, 304, and 306 of the Municipal Code and, if such election is not held as above provided, the councillors shall be appointed by the Lieutenant-Governor in Council.

Election of mayor.

5. The election of the mayor of the said municipality shall be held in accordance with articles 330 and following of the Municipal Code.

Valuation rolls, &c., not affected.

6. The valuation rolls, electoral lists, proces-verbaux, assessment rolls, by-laws and other documents heretofore governing the territory above mentioned, shall continue to apply to the said municipality until amended, repealed or replaced by the council of the said municipality and copies thereof certified by the secretary of the municipalities of the parishes of St. Agathe des Monts and of St. Faustin, shall be authentic for all lawful purposes.

Apportionment of certain assets and liabilities.

7. The assets and liabilities of the said municipality and of the former municipalities of the parishes of St. Agathe des Monts and of St. Faustin, shall be apportioned proportionately to the respective value of the detached territory

as established by the valuation rolls in force at the time of such division.

8. The municipality of Ivry-on-the-Lake is hereby authorized to borrow the sum of five thousand dollars for the purposes of paying the expenses of incorporation and for paying immediately to the municipalities of the parishes of St. Agathe des Monts and of St. Faustin, its proportion of any liabilities that may exist, the balance to be used for local improvements as the council may deem fit and proper. Loan for certain purposes.

9. Notwithstanding article 283 of the Municipal Code, every person who has resided in the municipality for three months in the year preceding the elections and possesses the other qualifications required, shall be qualified to fill the position of municipal councillor or any other municipal officer. Qualification for councillors.

10. The office of the municipality and that of the secretary-treasurer may be in the village of Ste. Agathe des Monts. Office of municipality, &c.

11. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 79

An Act respecting the parish of St. Dunstan of Lake Beauport.

[Assented to 14th March, 1912.]

WHEREAS, John Murphy, Charles E. Smith, Peter McNeil Preamble.
Simons, William Sangster and George Jewell, all farmers, of the parish of St. Dunstan of Lake Beauport, in the county of Quebec, have, by their petition represented, that they, with other proprietors and ratepayers, already form part of the municipality of St. Dunstan of Lake Beauport, erected by proclamation dated the 15th June, 1853; that the inhabitants of that place are in great majority English speaking and of English origin and that, in consequence of the religious and civil erection of the parish of Notre-Dame des Laurentides, their number has been decreased to less than three hundred souls and they have lost their existence as a separate corporation;

Whereas there may be doubts whether the county council can incorporate the inhabitants of the said territory as a distinct municipality;

Whereas it is expedient, in view of the exceptional circumstances in which the petitioners are placed, to erect the territory
